### North Lamar Trustees call school bond to address aging schools



Paris, Texas, February 9, 2021 – The North Lamar ISD Board of Trustees unanimously voted to add five propositions to the May 1 election ballot for a bond referendum. A bond was called for May 2020 but was cancelled due to the pandemic. If approved by voters, the new proposal will address aging school facilities, new bus replacements, student devices and energy efficiency. It has been 12 years since a bond passed at NLISD. That one provided \$4.68 million for four new science labs, five new computer labs, and repairs and improvements to the North Lamar High School.

The North Lamar ISD Community Advisory Committee recommended Trustees consider a bond proposal after the group spent over a year studying and prioritizing the district's most critical facility needs. This group of parents, grandparents, graduates, staff, business owners, ministers and community members volunteered and donated countless hours to examine needs and develop a plan. They toured schools, studied reports and evaluated the condition of existing buildings. The Committee's efforts provided the district with a Master Facility Plan and a recommendation to the Board of Trustees on how to address facility needs through a bond proposal.

#### The bond proposal projects include:

- 15 new buses to replace current fleet that are past their useful life;
- the construction of a new energy-efficient elementary school with a storm shelter
   for 650 students in grades 2-5;
- the renovation of Everett Elementary for PK-1 that includes an updated exterior,
   new roof, restrooms, HVAC, and intercom system for increased safety;
- upgraded safety and security features around the district, replacement of end-of-life
   HVAC units, repairs to the high school auditorium, gym, and athletic facilities along
   with a fine arts addition at North Lamar High School;
- repurpose Bailey Intermediate;
- and Chromebooks, iPads and charging stations so that every student can participate
   in interactive and remote learning.

Community Advisory Committee member **Aaron Barnes** said serving on the committee was an eyeopening experience. "I was impressed by the transparency of the entire process of creating the
bond package," said Barnes, a North Lamar parent and graduate of the district. "Having the
administration, our school board, and our advisory committee totally unified around this bond
package makes me very excited for the future of our district."

Superintendent **Kelli Stewart** commends the Community Advisory Committee for the time and energy they put forth to help develop a master plan that Trustees could consider. "State standards are increasing every year, and we strive to progress beyond to provide a modern teaching and learning experience here in North Lamar ISD. It's been rewarding to watch our community and Board work together to build this plan." said Stewart. "It's a critical step and I know the Board has weighed all the options."

School districts in Texas have two budgets: one for maintenance and operations (M&O) and one for capital improvements (I&S). School boards can consider rates for the I&S budget after voterapproved bond referendums. Currently, NLISD has a zero I&S tax rate. If voters approve all five propositions in May, the financial impact to taxpayers will be \$27 per month on a \$100,000 home. Property owners that are 65 years of age and older would not be impacted if they have filed for and received a homestead exemption with the state of Texas. Their taxes are frozen.

# Voter Key Messages



#### **HIGHLIGHTS**

#### BY THE COMMUNITY, FOR THE COMMUNITY!

The Community Advisory Committee, made up of 33 diverse community members representing all areas of the community, worked for over 12 months to study and prioritize the District's most critical needs. Their work culminated in a Master Facilities Plan which will address facility issues for the next 10 years.

This bond is largely their recommendation to the Board of Trustees and the proposal addresses six key things:

- New Elementary School Grades 2-5
- Address Aging Facilities
- New Buses
- Technology
- Energy Efficiency
- Safety & Security
- Community Advisory Committee:
  - 33 people / 8 meetings over two school years
  - Committee members included community leaders, business owners, parents and staff.
  - The committee studied and prioritized the district's most critical needs and made a recommendation to the Board of Trustees on how to address three goals:
    - 1. Provide capacity for 10-year projected student enrollment growth,
    - 2. Support the District's education improvement efforts, and
    - 3. Develop a recommendation to address facility needs.

#### **IMPACTS EVERY STUDENT IN THE DISTRICT**

The proposal includes upgrades at every school, every district facility, and impacts every student and teacher in NLISD.



#### IT HAS BEEN 12 YEARS SINCE THE LAST BOND

The last bond program was in 2009 for \$4.68 million to build classrooms for science, math and computer labs at the high school to meet the TEA 4x4 requirements. The last significant investment in school facilities was in 1995 to build the high school, which is 26 years ago. Most elementary schools have not had an investment since they were built almost 50 years ago. If voters approve, the 2021 Bond Proposals are only the eighth investment in public schools in NLISD history.

**VOTE THE ENTIRE BALLOT (pending Ballot)** 

#### PROPOSED PROJECTS WOULD ALL BEGIN IMMEDIATELY

- Design of renovation projects and new elementary school will begin immediately with construction activities beginning in the first months of 2022. Construction projects have been planned to keep students in permanent buildings, utilizing summers, and campus-wide sequencing.
  - Buses and Technology Procured Fall 2021
  - New ES Open Fall 2023 (Starts Construction 2/2022)
  - o Athletic Improvements Summer 2022
  - o Frank Stone Improvements Summer 2023
  - o Everett and Parker Open Fall 2024
  - o Repurpose Bailey Open Fall 2024
  - HS Fine Arts Addition Open Late Spring 2025
  - HS Improvements Open Fall 2025
- All buses will be purchased starting in 2021 to get the district on a regular replacement schedule.
- All student devices will be purchased in 2021 and distributed as needed so every student will have access to a laptop or iPad for school use.

#### **GRADE ALIGNMENTS**

Currently the district's four elementary schools have different grade alignments and some students change schools three times before they get to middle school. Proposition A could allow the district to create more consistent grade alignments in their elementary schools which will increase student performance and collaboration among teachers. With a strong desire to foster positive relationships between students, parents, and staff, we believe that having students remaining on the same campus for longer periods of time will help North Lamar better support families in all areas, including, but not limited to, academics and social emotional development.

- New campus built on land owned by the district to the north of the High School with a student capacity

#### ADDRESS AGING SCHOOL FACILITIES

The average age of a school building in North Lamar ISD is 47 years. These proposals address age-related facility issues and provide students with adequate learning environments.

#### RENOVATE EVERETT ELEMENTARY GRADES PRE-K - 1

\$8.5M

- Campus built in 1975. It is approaching 47 years old with no significant investment since it was built.
- Upgrade intercom system for safety and security fire alarms, surveillance cameras
- Renovate and relocate existing restrooms, roof & HVAC replacements, new gym floor, electrical upgrades, ADA accessibility upgrades, exterior doors, windows
- New brick exterior, new front entrance canopy, site drainage, enclose north exterior canopy with a new corridor

#### **PARKER ELEMENTARY**

\$2.2M

- Campus built in 1940.
- Roof and HVAC replacements, additional insulation to the building, new canopies for student drop-off,
   ADA accessibility upgrades, repair gym wall
- New electrical panel and technology infrastructure that includes expanding Wi-Fi access points,
   cabling, terminations, pathways, network equipment to accommodate for student and teacher devices
- New fire alarms



#### REPURPOSE BAILEY INTERMEDIATE

\$675,000

- Campus built in 1986. This campus will provide centralized office space for district professionals in intervention and therapy services and house the Deaf Education program. NLISD currently provides these services to its students and two neighboring school districts.
- New safety and security features such as fire panel, ADA accessibility, and new sidewalks
- Demo north wing and gym/fine arts and replace with grass

#### **DEMOLISH HIGGINS ELEMENTARY**

\$245,000

The foundation at Higgins ES is cracked and breaking away from support piers, and engineering studies have determined that it is structurally deficient and failing. In parts of the buildings, the floor is sloping so much that furniture is leveled out using wood shims. It is no longer feasible to fix the foundation without tearing down most of the school, which would cost almost as much as building a new school

FRANK STONE MS \$3.7M

- Upgrade intercom/bell system and ADA accessibility for increased safety
- Replace roof and 24 HVAC units, restroom upgrades, new gym floor (A), electrical service and panel upgrades, and site drainage

#### **NORTH LAMAR HIGH SCHOOL**

\$3.95M

- Upgrade intercom/bell system, fire alarm panel and ADA accessibility for increased safety
- Replace gym floors, repair floor structure, and improve ventilation
- Replace lighting and sound system in auditorium
- Replace 38 HVAC units
- Exterior repairs for drainage, sidewalks to ECC building, drainage and lighting around Ag Barn, and new roof and fans for greenhouse

ATHLETIC UPGRADES \$2.1M

- Proposition D includes turf replacement at the indoor practice field, drainage and elevation of the football, baseball, and softball fields to prevent flooding and damage to the playing fields.
- Flooded fields result in missed class time, missed practice time, and lack of home field advantage in UIL competitions.
- Currently, NLISD has to rent baseball fields for home games at Chisum ISD when our field it too wet to play on at a cost of \$500 per game.
- The varsity baseball program has only had six home games out of 30 in two seasons. The field conditions are unsuitable for practice or competition play.
- Athletic courses are taught by college-degreed, highly qualified teachers for high school graduation credit. Often these courses are taught in gyms or in outdoor classrooms like playing or practice fields.



FINE ARTS ADDITION \$4.2M

• Just over one-third of all high school students participate in fine arts programs like band, choir, and theater.

- The current band hall is half the size of recommended state standards, and other fine arts programs lack adequate instructional space as well. Band students currently practice and store instruments in the hallways, posing a safety concern during an emergency.
- Proposition E would provide for the construction of a new band hall and reconfiguring the existing band hall for shared use by theater, choir and band.

NEW BUSES \$1.8M

- Proposition B includes the purchase of 15 new buses and gets the district on a replacement schedule thru 2023.
- NLISD covers over 428 square miles, and its buses travel over 477,254 miles per year.
- 50% of students ride the bus to and from school each day.
- The useful life of a school bus in NLISD is 10 years, and 75% of the current fleet is approaching or past its useful life.

#### **TECHNOLOGY & MODERN LEARNING ENVIRONMENTS**

- Proposition C includes the purchase of 800 laptops, 275 iPads, and 27 charging carts
- This bond provides wireless access points, new student and lab computers, and servers for storage in the new elementary school, Parker and Everett ES.
- NLISD buildings were built to train for jobs and careers of the 1970's and '80's. Older buildings do not
  have the technology and electrical infrastructure needed for modern teaching and learning tools. We
  are preparing our students to compete in today's high tech economy, and students need access to
  devices in the classroom and at home.
- The pandemic has demonstrated that students need to have remote access to their learning to prevent performance drops. Currently, not every student has their own device to learn at home or while they are at school. This bond provides a 1:1 rollout of devices so that every student has a learning device.

#### **ENERGY EFFICIENCY**

This bond will provide end-of-life system replacements and will increase energy efficiency and lower operating costs.



#### **SAFETY & SECURITY**

- Modern safety and security features will be included at the new elementary and at Everett ES.
- Secure entryways, access card-reader systems, and centralized lockdown systems will be installed at the new elementary school.
- Updates will be made to fire alarms, intercom systems, exterior campus lighting, new surveillance cameras, and to increased handicap accessibility.
- Only three campuses in the district have fire detection systems NLHS, Bailey and Higgins.

#### FINANCIAL IMPACT

Prop A = \$14.92 per month for a \$100,000 home

Prop B = \$2.58 per month for a \$100,000 home

Prop C = \$.67 cents per month for a \$100,000 home

Prop D= \$3.00 per month for a \$100,000 home

Prop E = \$5.92 per month for a \$100,000 home

#### **65 & OLDER** (Use the house infographic to portray)

Property owners ages 65 and older who have applied for and received the over 65 homestead exemption will see NO TAX increase over their frozen dollar amount as a result of these bonds.

- NLISD has one of the <u>LOWEST</u> tax rates among its peer competition districts. (use Tax Comparison Chart)
- NLISD has **ZERO** I&S tax rate for capital improvement debt.
- NLISD has held and/or lowered the same total tax rate since 2007 (14 years).
- NLISD has had the same I&S tax rate for the last 4 years.
- Even after the passage of the bond, property owners will still pay a lower tax rate now than they did in 2006.
- Delaying implementation of the bond program exposes the District to escalating construction costs, which are expected to increase the total cost of the proposed bond projects by an additional \$3 million per year.

Don't encourage them "how" to vote.

#### **KNOW BOND INFORMATION RESOURCES**

Who to call, online content, print materials, etc.

#### VOTE!

As a registered voter, it is your privilege to make your voice heard.

#### **RULE OF THUMB**

After a school bond election is called, district employees are not allowed to use district-owned resources to advocate (encourage support or opposition). District-owned resources include your paid time, as well as all district equipment (telephones, computers, printers, copiers). However, you can share FACTS at any time.

#### **BE AFRAID TO SHARE FACTUAL INFO**

Talk about the bond and educate people on the facts, but only advocate after hours

A communication that advocates a particular outcome of an election. It can be a communication in almost any written or broadcast form, such as billboard, flyer, newsletter, poster, television or radio advertisement, email, or website.

# **FAQ**

#### North Lamar ISD May 2021 Bond FAQs

#### What is a bond?

A school bond is similar to a home mortgage. It is a contract to repay borrowed money over time with a fixed, tax-exempt interest rate. Bonds are approved by voters and sold by a school district to lenders/underwriters to raise funds to pay for the costs of construction, renovations, and equipment. Almost all school districts in Texas utilize voter-approved bonds to finance new facilities and major renovation projects.

#### How are bonds repaid?

Bonds are repaid by a debt service tax rate called the Interest and Sinking Fund tax rate, or I&S tax rate. It can only be used to service debt on school bonds and is not used to pay for staff or normal maintenance or operations expenses. The I&S tax rate is levied against the appraised value of taxable property in the district, less qualifying exemptions like a homestead exemption.

#### What is the payback period of the bond?

Prop A was based on a 30-year useful asset life and all other propositions were based on a conservative 5-year useful asset life.

#### What makes up a district's tax rate?

Funding for public schools in Texas comes from three main sources: local property taxes, state funds, and federal funds. The majority of funding for North Lamar ISD comes from local property taxes, which is comprised of two tax rates: Maintenance and Operations (M&O) tax rate and Interest and Sinking Fund (I&S) tax rate.

The M&O tax rate funds the general daily operations of the district such as salaries, utilities, gasoline, and supplies. It's all the things it takes to run a school district. School districts are a people-intensive business making salaries the largest part of the M&O budget. More than half of our staff are teachers.

The I&S tax rate is also referred to as the debt service tax rate. Funds generated from this tax rate pay off the debt of school bonds. This is similar to the part of the household budget that pays for the home mortgage. School bonds are issued as funds that are needed for voterapproved projects that include new construction and renovation of school buildings as well as technology infrastructure improvements.

#### Why did the foundations fail at Higgins Elementary and Bailey Intermediate?

- Moisture in expansive clay soils have induced vertical heave on floor slabs and some pier foundations
- Where floor slabs have incurred upward movement (piers without movement), it is compressing floor bearing walls into the roof and structure above. Because vertical movement varies throughout the building, many different conditions are present including doors not opening or stuck closed, walls pushing the structure upward causing roof damage, and walls spanning over floor depressions.

- Where piers have incurred upward movement, various issues have occurred from pushing floor slabs vertically to piers breaking the floor slab and attempting to penetrate the floor. Both observations are creating various vertical movements inside the building and at the roof structure.
- The overall effects of foundation damage are due to the presence of moisture in the soils under the building and the presence of groundwater.

#### What is the total amount of the bond program?

The total amount of the bond program is \$51,550,000. However, the projects that make up the bond program are broken into five separate propositions for voting. A voter may vote for or against any or all of the propositions individually.

Proposition A is for \$43,070,000 and includes Parker ES Improvements, New 2<sup>nd</sup> – 5<sup>th</sup> Grade Elementary School, Renovate Everett for PK-1<sup>st</sup> Grades, Demolish Higgins, Repurpose Bailey, Stone Middle School Improvements, and North Lamar High School Improvements.

Proposition B is for \$1,800,000 for new buses.

Proposition C is for \$405,000 for Technology Devices.

Proposition D is for \$2,075,000 and includes Resurface of Track, Improvements to Baseball Field, Improvements to Softball Field, Improvements to Football Field, and Improvements to Indoor Athletic Facility.

Proposition E is for \$4,200,000 for High School Fine Arts Addition.

#### What process was used to determine the bond program?

The District sought the input of a group of citizens who met regularly to review the results of past facilities studies which led to a long-range plan to address facility needs. The Community Advisory Committee included 33 members and was comprised of teachers, parents, business owners, senior citizens, partner institutions, professional and civic organizations, and other community members. The Committee members met from November 2019 to January 2021 to examine the district's facility needs, enrollment projections, vision for curriculum and instruction, safety and security, technology, and financial capacity. The Committee's recommendations focus on academics, fine arts, athletics, technology, and transportation. This Committee ultimately recommended that the Board of Trustees call for a bond election.

#### When would construction begin and end on projects?

Design of renovation projects and the new elementary school will begin immediately, with construction activities beginning in the first months of 2022. Construction projects have been planned to keep students in permanent buildings, utilizing summers, and campus-wide sequencing.

- New ES Open Fall 2023 (Starts Construction 2/2022)
- Athletic Improvements Summer 2022
- Frank Stone Improvements Summer 2023

#### When will the new tax rate go into effect?

The election will be held on May 1, 2021, and your taxes will not change until you receive your tax bill in October 2021.

#### How am I financially impacted if I'm over 65 years old?

According to state law, the dollar amount of school taxes imposed on the residence homestead of a person 65 years old or older cannot be increased above the amount paid in the first year after the person turned 65. This amount remains the same regardless of changes in tax rate or property value unless significant improvements are made to the home. Individuals 65 and over must apply for this exemption.

# **NLISD Challenges**

- Aging buildings cost more to maintain & operate increasing funds from the M&O budget and diverting funds from the classroom and instruction.
- Older buildings cannot support the electrical load for every student to have their own learning device.
- Declining enrollment over the last five years has created a drop in funding.


