### SHAC Public Meeting Minutes (Curriculum Building)

Jayson Coward called the meeting to order.

Attending: Cole Barker, Leddy Carder, Angela Chadwick, Keitha Chalupa, Jayson Coward, Shanon Erickson, Dee Hudson, Alicia Rouse, Kendra Waldroup, Kate Chadwick (Phone call)

Each attendee read the December 15, 2021 SHAC meeting minutes included in handouts. Shanon Erickson made a motion to approve minutes as read, Leddy Carder seconded, the motion carried.

#### OLD BUSINESS

- Recess Committee Recommendations Report (Extra handouts) Angela Chadwick read for recording– Thanks to committee members for laser focus on students need for recess.
  - Recommendations sent to four elementary campus principals for review and consideration, will share Principal's review comments with NLISD Board
  - Minutes in school are inclusive of recess for class scheduling
  - To avoid wasted time traveling to playground, maybe have other options in class to promote physical movement, i.e. video with dance or exercise
- Health Education Adoption – Posted as Open Public Meeting
  - Angela Chadwick – Textbook committee members share thoughts regarding attendance at Region 8 ESC Vendor Fair for Health Education Textbook Adoption. The group attended Goodheart-Wilcox (GW), McGraw-Hill (McGH), ESTEEM, and Lessenbee presentations and focused on grade 6 health class textbook options available.
  - Two full-year books presented GW & McGH, both covered 100% of TEKS. All committee members who reviewed textbooks in detail agreed:
    - GW – Had much more In-depth detail than needed for grade 6. About 300 pages longer than current textbook being used, TEEN HEALTH. It would be difficult to teach all material in one year
    - TEEN HEALTH, McGH: Best grade 6 option – New options Tech savvy – app allows downloads, so lack of internet availability is not a problem. Overall good coverage for situations relating to grade 6, incorrect information given regarding women's reproductive cycle, abstinence (note for later discussion), choking lesson incorrect for adults, possibly look at supplemental options versus teach from incorrect textbook
  - Campus planning is to imbed teaching of 100% of TEKS including new TEKS for grade 7 & 8. Resources are different for each grade level.
  - Consider protecting teachers regarding parental disagreement for a particular topic in textbook. Supplemental material shown at Vendor Fair is the additional Human Sexuality option. NLISD Board must state policy regarding Human

Sexuality instruction. District is required to teach 100% of TEKS. Supplemental materials were not considered, human sexuality instruction.

- Thoughts – SHAC members – Any major errors for GW? Issues are heavy language and much more detail than necessary for grade 6, more topics not in TEKS or goes beyond TEKS and grade level. Suggestion made to have access to book but not teach all topics in that book. GW is a better resource for grades 7 & 8. Currently discussing options with one semester health for grade 6 and one semester for grades 7 or 8. Both resources can be purchased.

Board Adoption Policy – Human Sexuality Instruction Requirements – waiting on policy update from TEA to make decisions regarding NLISD policy.

Grade 5 TEKS - merge teaching health instruction with PE course.

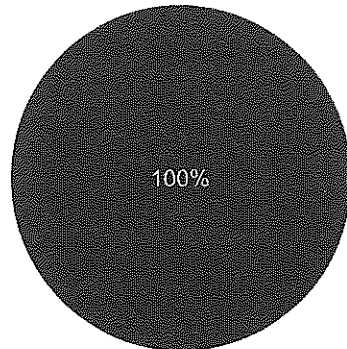

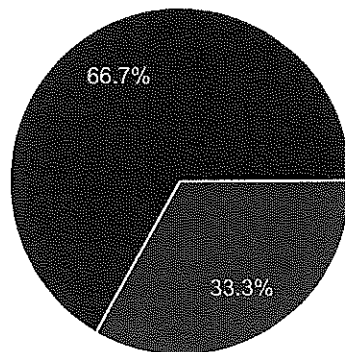
