Meeting Minutes

The Board of Education of Unified School District No. 265, Sedgwick County, Goddard, Kansas, met at 5:15 p.m., on Monday, September 14th, 2015, for a Board of Education and Legislator meet-and-greet in the Board of Education Room of the USD 265 Administration Center and for a regularly scheduled BOE meeting. 1. Call to Order

BOE President Kevin McWhorter called the meeting to order at 5:15 p.m.

Mrs. Pankratz came and visited him on a day when there was a sub. The next day, the student lit up as he told the story about Mrs. Pankratz coming to visit him. She made a huge difference in this student's transition and kept her promise, going above and beyond in building a positive, lasting relationship.

Further, a full 20% of the fiscal year's revenue is not received until June, the final month of the fiscal year, making it necessary to carry enough cash to make timely payments.
