

Debbie Cole Trade Scholarship 2022 Guidelines

HILCO created the Debbie Cole Trade Scholarship to encourage and assist in the educational pursuits of HILCO members and their families.

Eligibility:

Applicant must be:

- ♦ A resident of the state of Texas.
- ♦ Considered a dependent, living at the residence of their parents or legal guardians who are active member-consumers of HILCO Electric. They must be receiving electric service from the cooperative at their permanent address.
- ♦ A graduating high school senior.

If you are selected to receive the scholarship, you must:

- Enroll in the first fall semester after receipt of the scholarship.
- Meet entrance requirements of the school to which you apply.

Guidelines:

- ◆ Complete the HILCO Electric Scholarship application.
- ◆ Submit an essay of approximately 300 words detailing

"Someone in your life that has inspired you with their strong work ethic, and how that has influenced you in choosing a career requiring a skilled trade."

Judging Criteria:

Applicants will be judged on the following:

- ♦ Financial need.
- ♦ Academic excellence.
- Involvement in extracurricular activities.
- Support of community and family life goals.
- Content of essay.

Other Issues:

- ◆ Applications will be submitted to the selection committee in an anonymous format and graded on the criteria mentioned above.
- ♦ Applications will be accepted no sooner than April 1st and no later than April 15, 2022.
- ♦ Notification process will begin on or before May 11, 2022.
- ♦ If name(s) appear anywhere other than the Personal Information Sheet the applicant will be disqualified.
- One applicant will be chosen and awarded a one-time \$1000 scholarship.
