<u>Information</u> -- During this past year, the Adult Basic Education Program has been successfully housed at the Presbyterian Church Annex. The District needs to contract with the Presbyterian Church for the 2016-2017 school year to rent their annex for Adult Basic Education.

Item -- DISCUSSION, CONSIDERATION AND POSSIBLE ACTION TO APPROVE A GENERAL TRADEMARK ASSIGNMENT BETWEEN THE POTEAU QUARTERBACK CLUB AND POTEAU PUBLIC SCHOOLS, UNDER WHICH THE POTEAU QUARTERBACK CLUB WILL ASSIGN AND TRANSFER OWNERSHIP OF CERTAIN TRADEMARKS TO POTEAU PUBLIC SCHOOLS AND POTEAU PUBLIC SCHOOL WILL PAY \$552 TO THE POTEAU QUARTERBACK CLUB TO REIMBURSE IT FOR THE COSTS AND FEES INCURRED IN REGISTERING THE TRADEMARK WITH THE OKLAHOMA SECRETARY OF STATE.

<u>Information</u> - - The Quarterback Club purchased the rights to use certain trademarks for fund-raising activities. The school attorney has developed an agreement for the school district to purchase the rights for use by the school. <u>Recommendation</u> - - The board review the agreement for possible approval.
