V. <u>Item</u> - DISCUSSION AND VOTE TO APPROVE OR NOT APPROVE A RESOLUTION DETERMINING THE MATURITIES OF, AND SETTING A DATE, TIME AND PLACE FOR THE SALE OF THE \$1,700,000 GENERAL OBLIGATION BUILDING BONDS OF THE SCHOOL DISTRICT.

<u>Information</u> - - Our bond advisors McDonald and Associates have sent a resolution setting a time and date to approve the next series of building bonds for the new classroom buildings.

Recommendation - - The board vote to approve the Sale of the Bonds on June 16th At 1:00 pm.

VI. <u>Item</u> - - DISCUSSION AND VOTE TO APPROVE OR NOT APPROVE A BID FOR THE ROOFING PROJECT AT PANSY KIDD MIDDLE SCHOOL.

<u>Information</u> -- The roof at PKMS has deteriorated to the point of needing to be repaired or replaced. The bid notice gives the district flexibility to prioritize the needs of the separate buildings that make up the Middle School. The sealed bids will be opened on Friday, May 8th.

WHEREAS, the issuance of \$14,875,000 of General Obligation Building Bonds by Independent School District Number 29 of LeFlore County, Oklahoma, has been duly authorized at an election held on the 8th day of January, 2019, for that purpose; and

WHEREAS, \$1,600,000 of the \$14,875,000 has previously been sold, issued and delivered, and the Board of Education of Independent School District Number 29 of LeFlore County, Oklahoma, now desires to sell a second installment of \$1,700,000;

Now, therefore, be it resolved by the Board of Education of Independent School District Number 29 of LeFlore County, Oklahoma:

In accordance with 62 O.S. 2011, § 354, notice is hereby given that the Board of Education of Independent School District Number 29 of LeFlore County, Oklahoma, will receive bids by: sealed bid, facsimile bid, electronic (Parity®) bid or similar secure electronic bid on the 16th day of June, 2020, at 12:45 o'clock p.m., at the Bert Corr Administration Building, Poteau Public Schools, 100 Mockingbird Lane, Poteau, Oklahoma, for the sale of \$1,700,000 of General Obligation Building Bonds of said School District, which Bonds will mature \$825,000 annually in two (2) years from their date, and \$875,000 annually each year thereafter until paid.
