Meeting was called to order at 4:20 p.m.

Principal's Report given by Mitzi Smith:

- *This is a busy time of year and there are a lot of fun things happening at CDS right now.
- *Some possible new board members for next year include Daniella Bell and Melissa Nugent. Current members Cindy Gordon and Becky Klassen will no longer have children at CDS next year.
- *The foyer of the building is getting a makeover. The walls are being repainted blue and white. This money is coming from Mrs. Smith's Building Allocation fund as well as PTO. Treasurer's Report was given by Becky Klassen:

- *Becky read over financial statements and she passed out copies of these numbers to everyone.
- *The profit from Chocolate Sales is approximately \$2900. There is a small remainder of candy bars that are being sold by Mrs. Smith in the morning and that money will go to her fund as she is the one that is doing all the work regarding those sales. She uses that money for various things throughout the year that have not been authorized expenses for PTO.

Fun Night profit is over \$4200. We are still waiting on \$150 from Cargill. Every year, the crowd gets larger and larger. Next year, cooking will begin earlier, more food will be purchased and extra bingo cards will be on hand.

- *Chick-fil-A profit was \$283 from the spinning wheel and \$263 from food sales.
- *Bowling night profit was \$269.
