 - iii. Fix fence damaged by downed tree; install new chain link fence around two sides of Elementary playground (where pipe fence is now)
 - iv. Install lights to better light playground, ag barn and other areas about campus
 - v. Build concrete handicap accessible ramps into the high school boys and girls restrooms. Ramps must be ADA compliant.
 - vi. Wiring and Installing a new smoke detection and fire alarm system in the Elementary School. Licensed electrician(s) are required.

No bids have been turned in at this moment. Mike Hall made a motion to allow Mr. Cline to accept a single bid on each itemized project listed. If there are more than one bid, he will accept the lowest bid. Danell Sims seconded the motion. Motion carried 6-0.
