Notice is hereby given that on the 17th day of November, 2022 the Board of Trustees for the Dimmitt Independent School District will hold a regular board meeting at 12:00 p.m. at the Dimmitt ISD Administration Office, located at 608 W Halsell, Dimmitt, Texas. The subjects to be discussed are listed on the agenda, which is attached to and made part of this notice.

If, during the course of the meeting covered by this Notice, the Board of Trustees should determine that a closed or executive meeting or session is required, then such closed or executive meeting or session as authorized by the Texas Open Meetings Act, Texas Government Code Section 551.001 et seq. will be held by the Board of Trustees at the date, hour, and place given in this Notice or as soon after the commencement of the meeting covered by this Notice as the Board of Trustees may conveniently meet in such closed or executive meeting or session concerning any and all purposes permitted by the Texas Open Meetings Act, including, but not limited to the following sections and purposes:

**TEXAS GOVERNMENT CODE SECTION:**

- 551.071 Private consultation with the board's attorney.
- 551.072 Discussing purchase, exchange, lease or value of real property.
- 551.073 Discussing negotiated contracts for prospective gifts of donations.
- 551.074 Discussing personnel or to hear complaints against personnel.
- 551.076 Consider the deployment, specific occasions for, or implementation of, security personnel or devices.
- 551.082 Consider the discipline of a public school child, or complaint or charge against personnel.
- 551.083 Consider the standards, guidelines, terms, or conditions the Board will follow, or will instruct its representatives to follow, in consultation with representatives of employee groups.
- 551.084 Excluding witnesses from a hearing.
- 551.086 Not required to conduct an open meeting for economic development negotiations.

**TEXAS EDUCATION CODE:**

- 39.030 Conduct a closed meeting to discuss or adopt individual assessment instruments or assessment instrument items.

Should any final action, final decision, or final vote be required in the opinion of the Board with regard to any matter considered in such closed or executive meeting or session, then the final action, final decision, or final vote shall be at either:

- a. in the open meeting covered by this Notice upon the reconvening of the public meeting; or
- b. at a subsequent public meeting of the Board upon notice thereof; as the Board shall determine.
