

Monahans High School Parking Regulations 2021- 2022

Vehicles on Campus: Driving to school and parking on the Monahans High School Campus is a Privilege and not a right. In order to register for a parking permit the student will need to bring a copy of insurance, Texas driver's license, and license plate number, for verification of eligibility for a parking permit. Cost of a parking permit for the 2020-2021 school year will be free. Due to construction, parking spaces are extremely limited. Spaces will be offered to seniors first and will be on a first come first serve basis. Seniors have the option of choosing their parking spot in the South Parking lot, across from the old cafeteria. Additional parking will be available to all students. These spots will be on a first come, first serve basis DAILY. ALL students parking on campus need a permit. A map will be provided to students of where these additional parking spots are provided. Seniors will have the option of painting a personalized parking spot for \$15 (see additional handout for Senior Reserved Painted Parking Spaces). The student will properly register the vehicle driven to school. The student will drive safely and responsibly and will not violate any school rules or laws concerning parking or operation of vehicles on campus.

- 1. Students may only register one vehicle
- 2. The senior painting parking spot must be paid by check, money order, or exact cash. We will not make change.
- 3. Parking permits must be displayed with the front facing outwards on the rearview mirror. Permits are non-transferable. Misuse of vehicle permit will result in loss of parking privileges and NO refund.
- 4. Students must paint your parking spot number provided to you by Mr. Amburn at the bottom of your parking spot. You can choose color/decoration of your choice but may not be larger than 12" x 12" (think a sheet of notebook paper) ... Must be school appropriate.
- 5. Lost permits must be replaced at a cost of \$15.
- 6. If you are temporarily driving a vehicle not registered, you must secure a temporary permit:
 - a. Get a temporary permit from Mr. Amburn
 - b. Pay \$1 per day for temporary permit (Only good for 1 day).
 - c. Return to your car and display temporary permit.
- 7. Students are not permitted to loan or sell permits to other students or to be in possession of more than one permit. Violations will result in loss of parking for the remainder of the school year and NO refund for any fees paid.
- 8. Students must inform Mr. Amburn of any permanent changes to vehicles and bring new car insurance and license plate number.
- 9. Vehicles parked on MWPISD properties will be subject to inspection and searches by school personnel, local authorities, and drug canines. The following items are never allowed on campus or school properties:
 - a. Weapons, including but not limited to guns, knives, or any type of ammunition.

- b. Illegal drugs, paraphernalia, prescription drugs, or over the counter drugs that in quantities that violate MWP ISD policy
- c. Alcohol
- d. Tobacco products including but not limited to cigarettes, vape pens, e-cigarettes, tobacco pods.

10. SPEED LIMIT ON CAMPUS IS 5 MPH.

- 11. Students should make sure that their vehicle is locked at all times as students are responsible for ALL items in their vehicle.
- 12. Students may not go to their vehicle during school hours without written permission from a campus administrator (except when leaving school for the day, athletics/other classes, and lunch).
- 13. Vehicles found in violations or rules may/will be towed at the owner's expense.
- 14. Furthermore, the student understands that school officials have the right to suspend or revoke their driving and/or parking privileges on campus or MWPISD properties for violations of registration, driving, or parking infractions set forth by the State of Texas, City of Monahans, and MWPISD policies and procedures, Student Code of Conduct and Student Handbook.

Violations that will result in ticketing/towing:

- a. Not displaying correct permit
- b. Not parking in appropriate parking space, blocking drives, entrances, etc.
- c. Abandoned or inoperable vehicles.

Important:

If a tow truck is called to remove a vehicle and the owner/driver of the vehicle appears before it is actually hooked up and towed, the wrecker will proceed with the towing unless the owner/driver of the vehicle can make satisfactory financial arrangements with the driver as per TDLR. Otherwise, all cost associated with towing are exclusively the responsibility of the owner/operator of the vehicle. Any student parking in a handicapped spot (without proper documentation) or in faculty, staff, or visitor spot will be towed.

Student must Acknowledge That:

I have read and fully understand the regulations for parking at Monahans High School and MWPISD properties. I am aware that the privilege to park on school property may be revoked for failure to observe safety precautions or stated rules, as well as for **disciplinary reasons**. I am also aware that such permission does not constitute an acceptance of responsibility by Monahans High School or MWPISD for loss of personal property or damage to the vehicle while on school property.
