III. RECOGNITION

1. Teacher of the Year

Dr. Palmer, Superintendent of Schools, introduced Allison Pregman, Weston 2015 Teacher of the Year.

VI. NEW BUSINESS

1. Presentation of District Update

Dr. Palmer, Superintendent of Schools, provided a detailed update to the Board on district work in key areas: purpose, framework, and 2014-15 areas of focus of the Master Planning Team; district goals progress and next steps through work of the Master Planning Team, administrators, schools, and Board; key factors that impact

district work; and resource allocation and budget implications for 2016. Discussion by the Board followed.

2. Annual NESDEC Enrollment and Projections Report

Dr. Palmer, Superintendent of Schools, reviewed the NESDEC Annual Enrollment and Projections Report, including factors affecting enrollment, birth to kindergarten ratios, a review of current year enrollment, projections for next year, and preschool feedback. This report is the updated enrollment history and forecast from the New England School Development Council (NESDEC). These enrollment projections, developed annually, provide important data for program, budget planning and staffing for the 2015-2016 school year. Discussion by the Board followed.

3. Second FY 2015 Financial Update and Approval of Transfers

Dr. Keating, Director of Finance and Operations, provided a monthly financial update, including transfers for physical therapy services, SAT proctors, shipping costs for textbooks, and repairs.

2. Principals' Reports

Mrs. Kaddis, Hurlbutt Elementary School Principal, discussed parent math workshops. Ms. Falber, Weston Intermediate School Principal, highlighted Veterans Day activities. Ms. Watkins, Weston Middle School Principal, reported on two guest speakers – a NASA scientist, and an engineer. Mrs. Deorio, Weston High School Principal, discussed school counseling newsletters, field trips, and alumni updates.

1. WHS Student Representatives Report

Mr. Seigenthaler and Mr. Marvin commented on the success of *The Laramie Project* and the post-performance discussion with an original cast member, community service fundraisers, a student survey with ideas for improving Weston High School, and girls soccer.

2. Communications Committee

Ms. Daniel announced the Realtors' Open House scheduled for January 14, and highlighted the recent *Weston Forum* insert. The next Committee meeting is scheduled for December 12.

3. Curriculum Committee

Dr. Craw, Assistant Superintendent, discussed the following topics from the November 12 meeting: new course proposals for AP Latin, a second coding course, and a ninth-grade geophysical sciences. The next Committee meeting is scheduled for December 10.

4. Finance Committee

Ms. Harvey discussed the following topics from the November 11 Finance Committee meeting, in addition to those covered by Dr. Keating previously on the agenda: FY 2016 budget preparations, security grant update, substitute teacher compensation structure, qualifications for a health insurance consultant, RFP for the food service contract, transportation contract, fleet maintenance, and the Entrepreneurial Goal Committee. Discussion by the Board followed. The next Committee meeting is scheduled for December 4.

5. Facilities Committee
