Green Forest Intermediate School invites, consults with, and involves parents in the annual Title 1 evaluation and process and the evaluation and formation of the School Parent and Family Engagement Plan. The Green Forest Intermediate encourages effective parental involvement and evaluates parental involvement and evaluates parental involvement efforts through this annual process using a comprehensive needs assessment that is filled out by teachers, parents, and school staff prior to the end of the previous school year and then analyzed and discussed for development and implementation in the following school year.

The Title I committee is made up of teachers, parents, students, and other school staff, and this committee determines the quality and effectiveness of the School Parent and Family Engagement Plan by reviewing the plan, developing the plan, and making any changes or improvements to the plan.

Green Forest Intermediate makes efforts to collect data and information from parents through surveys regarding the effectiveness of the School Parent and Family Engagement Plan. Green Forest Intermediate School will conduct an annual, stand alone, Title I Meeting (Part A, Act 397) in November of 2019 to inform parents of the requirements of the Title I program and the school's participation in it. It addresses the goals for the Title I program, the rights of the parents to be involved in the planning, review, and improvement of parental programs, as well as the ability of the school to consolidate funds from federal, state, and local sources.

Parents will be provided information about the following components: a) Parents Right to Know (a requirement letting parents know the qualifications of individual teachers posted on the Green Forest School District's website), b) Annual Report Card (this is the report card for the district, which tells how all schools performed on the spring 2019 ACT Aspire Assessment. The school will use the student handbook, school web site, signage at the school entrance, and parent orientation meetings about the Schoolwide Title I Plan and how to get a copy upon request.

The school will provide to each classroom teacher of students in grades K-5 a red folder which will contain student papers and work samples for parents to review and sign each week.

Parents can access their student's grades using Home Access Center (HAC) using login information they received at the beginning of the school year.

The school will schedule Parent Teacher Conferences to be held twice a year. During these conferences, teachers of students in grades K-8 share a report detailing the student's performance level in reading and math.

The school will provide to parents a progress reports/report cards every five weeks with information regarding their student's academic progress.

Parents may use email to communicate with members of the school staff.

Translators will be utilized as much as possible to communicate with families.

School staff, parents, and students will develop a school-parent-student compact. Ongoing two-way communication is maintained through the use of red folders sent home each week with students. The school website is available for parents and community members to use to stay informed of upcoming events and activities. Parents can use email to communicate with teachers through the website. Parents are given information about how to access their student's grades and attendance using Home Access Center (HAC) during the first nine weeks. Letters or informational flyers are sent home with students and posted on the district website and Facebook page announcing parent meetings connected to the Title I program and also parent involvement activities.

Parent assistance and volunteering is encouraged and supported in order to provide a conducive environment for students. Brief training sessions are provided for parents that participate and are interested in volunteering in our school.

Parents and families are encouraged to participate in field trips, classroom activities, literacy nights, and other family nights. Our district provides classrooms for two ABC pre-school classes in partnership with the OUR Educational Cooperative. This allows us to foster relationships early with future students and parents. In partnership with the University of Arkansas Division of Agriculture, the county extension office provides nutrition lessons for students.

Community resources will be utilized to strengthen school programs. This includes: local churches donating clothing and other student supplies; Loaves and Fishes providing food for take home backpacks; Youth Bridge counseling services housed on campus to serve student mental health needs; and Blessing Box containing food and books provided by local churches.

All stakeholders are engaged throughout the year in creating, advising and amending the plan to provide a comprehensive and coordinated parent and family engagement plan.

An explanation and description of the curriculum in use is included in the student handbook which is passed out to all students and must be signed upon receipt. The handbook is posted on the district website in English and Spanish to provide access for all. Curriculum and assessment are discussed during the Annual Report to the Public. Individual student assessment results from all state and local assessments are given to parents and filed in each student's permanent file. Results are interpreted and analyzed by staff and students are placed in RTI and enrichment classes accordingly. Student Success Plans, Intensive Reading Interventions, and Individual Reading Levels are shared with parents during Parent Teacher Conferences. Parents are given pamphlets and information explaining the state assessments and measurements used to identify, track and sustain growth for all students. Strategies and study skills and methods parents can use to support academic progress will be communicated through various links on the district website including DESE website and tools for parents and through conversations with teachers. Parents are provided information from our cafeteria and food service director in the handbook and through handouts that provide information and assistance with nutritional meal planning and preparation.

Professional development requirements are met annually for teachers and administrators. A signed copy of each teacher's professional development plan is given to the administrators to review.

The parent facilitator will help organize meaningful training for staff and parents; promote and encourage a welcoming atmosphere to foster parent and family engagement in the school; awareness of importance for effective communication skills; value and inclusion of parent contributions as equal partners; and to understand

efforts that parental participation is recognized as an asset to the school.

Classroom teachers will routinely contact parents on an individual basis to communicate about their child's progress through email, notes, conferences, and/or phone calls. Parents and community members were invited to attend the Parent Advisory Committee Meeting/Report to the Public obtain input on our core beliefs, promises, mission, and shared vision.

Literacy training is provided for teachers and paid for by the district to improve instructional strategies in the classroom as well as share best practices with families.

Parental involvement activities such as literacy night, and family nights are funded by the school so that parents can attend. School meetings, such as parent-teacher conferences, are offered at a variety of times (3:15-8:15PM). If parents are unable to attend at those times, teachers work collaboratively with parents to schedule a better time. When parents are unable to come up to the school for a conference, administrators and teachers will conduct in-home conferences to maximize parental involvement and participation in their children's education.

The parent engagement toolkit from Arkansas DESE website is used to model approaches to improve parent and family engagement.

Community-based organizations and businesses will be involved in parent and family engagement activities through the use of donations as well as attendance in events.
