

WPISD Flyer Approval Procedure

Wills Point ISD launched a new electronic flyer communication tool called "Peachjar" on September 12th, 2017. This "green" initiative is saving our schools tons of paper and has significantly reduce copying costs. Additionally, it has allow for flyer distribution that is more consistent across the district.

Flyer Distribution – Groups & Organizations Affiliated with Wills Point ISD

For groups and organizations affiliated with Wills Point ISD (parent-faculty organizations, athletic booster groups, band boosters, etc.), distributing eflyers through Peachjar will always be free. To submit flyers for approval and distribution, follows the steps below. Once approved, your flyer will be emailed to parents/guardians and will be posted online.

- Contact your district or School Site Peachjar Administrator
- When you are ready to upload a flyer, visit www.peachjar.com
- Login to your account.
- Upload your flyer for approval.
- Your flyer will be automatically submitted.

Flyer Distribution – Outside Community Groups & Organizations

Wills Point ISD cooperates with approved community partners by posting eflyers online and distributing them electronically through our service provider, Peachjar. As part of our efforts to be more environmentally friendly, embrace innovative technology, and maintain fiscal responsibility, we are eliminating paper distribution of flyers and transitioning solely to electronic delivery.

To request flyer approval, follow the steps below. Once approved, your flyer will be emailed to all parents/guardians and posted online. Paper flyers from outside organizations will no longer be distributed.

- When you are ready to upload a flyer, visit www.peachjar.com
- Upload your flyer for approval.
- Your flyer will be automatically submitted to the district office. District staff will review the material and approve or deny based on the standards below. Flyer approval will occur within 2 business days.

For outside community groups and organizations, electronic distribution of flyers is free for programs that are entirely free. For programs and events that have fees associated with them, Peachjar charges a fee for electronic distribution. This fee is typically much less than the cost to copy and deliver paper flyers to each school.

Flyer Guidelines

Flyers that are distributed by Wills Point ISD must meet the following guidelines:

- Support the basic educational mission of the district, directly benefit the students, or be of intrinsic value to the students or their parents/guardians.
- Flyer must be in PDF format and smaller than 6 MB.
- Flyer must contain the name and contact information of the sponsoring entity.

- Flyer must include the following disclaimer, which Peachjar automatically adds to flyers from outside organizations:
 - “This program, activity, product or service is not sponsored by or affiliated with Wills Point ISD.”

Flyer approval does not constitute endorsement. Approval simply means the material has been reviewed and meets the guidelines for districtwide electronic distribution. The district reserves the right to rescind approval to any organization or person if a complaint is received or the organization or person is found to be in violation of instructions from the YOUR Public Relations & Communications Office.

Flyers shall not be approved if they:

- Contain obscene material or are inappropriate for family viewing in a school environment.
- Promote products that are unlawful for minors to purchase or use, or businesses that are unlawful for minors to patronize.
- Promote projects, activities or programs that would publicize or promote a particular political party, political organization or political viewpoint.
- Are deemed inconsistent with School District policies or contrary to law.
- Would tend to disrupt the school environment.
- District has the final approval or denial, for any reason.
