- Parent Notification Letters (Annual & Initial)
 - Initial ELPAC letter states what score student received from district examine
- Annual ELPAC letter states scores from CAASPP, ELPAC and other annual assessments
- English Language Development Program and Instructional Materials
 Teachers are required to provide instruction to English Learners. Lessons are delivered by
 classroom teachers and are based on state standards. Students are provided with designated
 ELD workbooks to learn grammar, writing, etc. ELD instruction is integrated across all subject
 areas.

- English Language Development Goal 3, School Plan for Student Achievement Main job is to work on SPSA-general information, school vision and mission, school profile, comprehensive needs assessment and analysis, description of barriers, school goals, etc. We have series of goals for English Learners in reading, writing, etc.
- Uniform Complaint Procedure (UCP) & Williams UCP
 This document is posted throughout every room and classroom in the school. States that the school should be safe and clean. Students should have a teacher in the classroom and the necessary textbooks and supplies. If the school is absent of these items a complaint can be filed.
- LCAP Webinar
 School Districts in California are required to have a three year plan. This an accountability plan
