# Elkins School District Parental Involvement Plan 2016-2017

#### **FOREWORD**

It is the school district's responsibility along with the parents and guardians of a child to attend to the educational aspects of a child's life. Forming a solid partnership with the district, the child and the child's family is critical to ensure the academic, social, ethical, and critical problem solving success of our children as reflected in our district mission.

Elkins School District's parents and guardians comprise a diverse group. They are all a most integral component of the district's drive to maintain and improve the academic, social, ethical, and critical problem solving skills for all children in our district.

Research reports and Elkins School District agrees that the more the parents and guardians of our children are knowledgeable and engaged in this process the greater the outcomes. The district plan will be disseminated by posting on the school web site in whole and postings are disseminated throughout the community on community post boards the announcement of parental involvement in our district as well as directions to access the building and district plans. The schools' plans are disseminated during the parent meetings.

The primary parental involvement facilitator and principal and the elementary parental involvement facilitator and principal along with the district federal programs director conduct an annual meeting in the spring to update plans for next year's Title I, Part A program.

The District Federal Programs Coordinator along with the building administrators and parent facilitators are responsible for ensuring and monitoring each school in the areas of parental involvement. The primary parental involvement facilitator along with the District Federal Programs Coordinator informs and coordinates parental involvement activities with our HIPPY program and local head start {Lisa Carper and Jane Vaught-Simmons (479)643-2172}

Parental involvement facilitators are identified at each school to act as contact persons who are responsible for conducting an annual review of the effectiveness of the parental involvement plans. (Primary: Lisa Carper, Elementary: Cindy Hubbs, Middle School: Amy Camp, High School: Amanda Coleman). The District Federal Programs Coordinator (Jane D. Vaught-Simmons (479)643-2172) is responsible for conducting an annual review of the effectiveness of the district parental involvement plan. As well, the District Federal Programs Coordinator develops a district parental involvement committee to create a parental involvement plan and implement parental involvement activities. The District Federal Programs Coordinator along with the Primary and Elementary Parental Facilitator (Cindy Hubbs and Lisa Carper) disseminates information to community promoting parental involvement in the Title I, Part A schools in a manner in which parents with disabilities may access these activities and parents of limited English proficiency have the same access as other parents including information in a language they can understand.

#### PARENT/GUARDIAN INVOLVEMENT PROGRAM GUIDELINES

The Parent/Guardian Program in the Elkins School District shall:

- The district shall involve parents/guardians of students at all grade levels in a variety of roles. The parental involvement facilitators coordinate many of the parent involvement activities. The facilitators inform the District Federal Programs Coordinator of these activities and site visits are conducted to observe these activities.
- 2. The district shall provide the coordination, technical assistance, and other support necessary to assist participating schools in planning and implementing effective parent involvement activities to improve student academic achievement and school performance. The activities will enhance the awareness and skills of the teachers, pupil service personnel, principals, and staff in reaching out to communicating with and working with parents as equal partners.
- 3. The district shall conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of the parental involvement policy in improving the academic quality of the schools served under this district, including identifying barriers to greater participation by parents in activities authorized by this section (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background), and use the findings of such evaluation to design strategies for more effective parental involvement, and to revise, if necessary, the parental involvement policies described in this plan.
- 4. The district shall conduct an annual survey to improve effectiveness.
- 5. The district shall recognize that communication between the home and the district should be regular, two-way and meaningful.
  - The district shall incorporate the Elkins School District Parental Involvement Plan into the district's and schools' annual comprehensive school improvement plan (ACSIP) with parent suggestions.

The District Federal Programs Coordinator oversees and asks for documentation of parental involvement times and activities. The District Federal Programs Coordinator is instrumental in reviewing and developing the district parental involvement policy. The District Federal Programs Coordinator with the school facilitators and guidance from State Federal Programs develops the school-parent compact. Two informational parent meetings are conducted each school year in our Title I schools to provide parents with information to improve their child's academic achievement and how to access their child's achievement status at flexible meeting times to accommodate parents. Letters are sent out to inform our parents of their child's attendance. Our district utilizes In Touch as well as our web site to communicate our parent meetings.

#### **BUIDLING CAPACITY FOR INVOLVEMENT**

- 1. Elkins School District shall ensure that each Title I school is monitored and performs the tasks required by Schoolwide Title I components.
- 2. Elkins School District shall ensure that each Title I school provides assistance to parents of children served by the school, as appropriate, in understanding such topics as the state's academic content standards and state academic achievement standards, state and local academic assessments, the requirements of Title I, how to monitor a child's progress, and how to work with educators to improve the achievement of their children. Parents' rights to request information relating to their child's progress, teacher qualifications and teacher meetings is disseminated among parents.
- 3. Elkins School District shall ensure that each Title I school develops a parent/teacher/student compact.
- 4. Elkins School District shall ensure that each Title I school provides materials and training to help parents to work with their children to improve their children's achievement, such as literacy training and using technology, as appropriate, to foster parental involvement.

- 5. Elkins School District shall ensure that each Title I school will educate teachers, pupil services personnel, principals, and other staff, with the assistance of parents, in the value and utility of contributions of parents and how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school. The district will assist the parental facilitators at each school (Primary: Lisa Carper, Elementary: Cindy Hubbs, Middle School: Amy Camp, and High School: Amanda Coleman) in the development of parent engagement groups at each school.
- 6. Elkins School District shall, to the extent feasible and appropriate, coordinate and integrate parent involvement programs and activities with Head Start, Home Instruction Programs for Preschool Youngsters, and other programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children.
- 7. Elkins School District shall ensure that information related to school and parents programs, meetings, and other activities is sent to the parents of participating children in a format and, to the extent practicable, in a language the parents can understand.
- 8. Elkins School District shall provide such other reasonable support for parental involvement activities under this section as parents may request.
- 9. Elkins School District and schools shall develop a policy and plan to involve parents. These will be available on both the district and school websites, in print or shared at public meetings.
  - 10. The parental involvement facilitator at each school is responsible for conducting the parent survey to identify barriers to greater parent participation and collecting the results. The District Federal Programs Coordinator is responsible seeing that this survey is conducted and collects each school's results to meet with building facilitators and identify strengths and barriers to greater parent participation. Then, planning activities to remove these barriers.

#### **6.11-PARENTAL/COMMUNITY INVOLVEMENT - DISTRICT**

The Elkins School District understands the importance of involving parents and the community as a whole in promoting higher student achievement and general good will between the district and those it serves. Therefore, the district shall strive to develop and maintain the capacity for meaningful and productive parental and community involvement that will result in partnerships that are mutually beneficial to the school, students, parents, and the community. To achieve such ends, the district shall work to:

- 1. Involve parents and the community in the development of the long range planning of the district;
- 2. Give the schools in the district the support necessary to enable them to plan and implement effective parental involvement activities;
- 3. Have a coordinated involvement program where the involvement activities of the district enhance the involvement strategies of other programs such as Head Start, HIPPY, Parents as Partners, Parents as Teachers, ABC, ABC for School Success, area Pre-K programs, and Even Start;
- 4. Explain to parents and the community the State's content and achievement standards, State and local student assessments and how the district's curriculum is aligned with the assessments and how parents can work with the district to improve their child's academic achievement;
- 5. Provide parents with the materials and training they need to be better able to help their child achieve. The district may use parent resource centers or other community based organizations to foster parental involvement and provide literacy and technology training to parents.
- 6. Educate district staff, with the assistance of parents, in ways to work and communicate with parents and to know how to implement parent involvement programs that will promote positive partnerships between the school and parents;
- 7. Keep parents informed about parental involvement programs, meetings, and other activities they could be involved in. Such communication shall be, to the extent practicable, in a language the parents can understand;

#### **A GUIDELINES**

1. Elkins School District shall conduct surveys annually involving parents input to assist our district in identifying barriers to parental involvement in an effort to remedy any barriers that exist. Elkins Primary and Elementary Schools shall provide opportunity for parents to submit any comments on the plan when the school makes the plan available to the Elkins School District, if the schoolwide program plan is not satisfactory to the parents of participating children. Parents shall be notified of the policy in an understandable and uniform format and, to the extent practicable, provided in a language the parents can understand. Such plans shall be made available to the local community and updated periodically to meet the changing needs of the parents and of the school. The parental involvement facilitator at each school is responsible for conducting the parent survey to identify barriers to greater parent participation and collecting the results. The District Federal Programs Coordinator is responsible seeing that this survey is conducted and collects each school's results to meet with building facilitators and identify strengths and barriers to greater parent participation. Then, the group is responsible for planning activities to remove these barriers.

- 2. Elkins Primary and Elementary Schools shall convene an annual meeting, at a convenient time, to which all parents of participating children shall be invited and encouraged to attend, to inform parents of their school's participation under this part and to explain the requirements of this part, and the right of the parents to be involved. At these meetings parents will be provided the opportunity to assist in the development of the evaluation procedures involved in progress monitoring and the way to best disseminate the data to parents.
- 3. Elkins Primary and Elementary Schools shall offer a flexible number of meetings, such as meetings in the morning or evening, and may provide, with funds provided under this part transportation, child care, or home visits as such services relate to parental involvement.
- 4. Elkins Primary and Elementary Schools shall involve parents, in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under this part, including the planning, review, and improvement of the school parental involvement plan and the joint development of the schoolwide program plan, except that if a school has in place a process for involving parents in the joint planning and design of the school's programs, the school may use that process, if such process includes an adequate representation of parents of participating children.
- 5. Elkins Primary and Elementary Schools shall provide parents of participating children:
  - Timely information about programs under this part;
  - A description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and the proficiency levels students are expected to meet; and
  - Requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practicably possible.

#### PARENTS/ GUARDIANS AND TEACHER CONFERENCES

To encourage communication with parents/guardians, the Elkins School District shall schedule not less than two (2) parent/guardian and teacher conferences per school year. The district and its schools may plan to engage in other activities determined by them to be beneficial in the fostering of effective communication with parents/guardians. Any parent/guardian that cannot attend either of these conferences are urged to contact the school building office for a rescheduled time to discuss their child's progress.

#### PROMOTING/SUPPORTING RESPONSIBLE PARENTING

The Elkins School District provides within each campus' parent resource center and parent libraries various pamphlets, videos, books, and magazines which may be taken or checked out by parents visiting school for any event. These materials are reviewed annually.

#### **PARENT RESOURCE CENTER**

The Elkins School District supports a Parent Resource Center at each school campus. Parent facilitators are available for assistance. Hours, building contact telephone numbers, and staff email addresses can be obtained through the building administration offices or on each school's website.

#### PARENT LIBRARY
