  - Revenue Sources:
    - Federal Reimbursement 83% of total revenue
    - State Reimbursement 6% of total revenue
    - Parent pay 11% of total revenue
  - Major Expenditures:
    - Personnel 59% of total expenditures
    - Food products and supplies 41% of total expenditures
  - The district has made a diligent, focused effort on reducing and eventually eliminating the contribution from base dollars to the School Lunch Program. Our newly hired Supervisor of CNS has made an immediate positive impact on kitchen efficiency, safety, reduced food costs, increased revenue and overall improvement of the entire program.
    - Staffing was reduced; A-la-carte has been added; Rim is now a member of the High Desert Co-op to lower cost of goods; overall to date reduction in expenditures is \$51,253!!
    - A new School Solutions platform will be implemented for the 18/19 school year that improves efficiency with sites sales, accounting and reporting due to the interface with our Student Information System (AERIES). Staff and parents will have easier access to apply for Free/Reduced lunch and fund student accounts and view student purchases.
    - CNS concerns: Borrowed meal sales to date total \$11,000. This is household debt to our district.
