Commissioner Fornal asked about the number of openings for the Instructional Assistants and if the district was in compliance, as well as, the plan to fill the positions. Commissioner O'Connell noted that the nature of the Instructional Assistants role makes the positions difficult to fill. It takes a special person with experience to support these hard to fill positions. Instructional Assistants work part-time, and while health insurance is offered, it is expensive, adding more difficulty for all districts to hire Instructional Assistants. Director Austin stated that there were several openings at all districts, with over 350 open Instructional Assistant positions in north county districts alone and are competing for the same pool of applicants. Director Austin explained that the district is backfilling the open Instructional Assistant positions with agency staff. Like other districts, Carlsbad Unified School District continues to continuously advertise and recruit for Instructional Assistants through various avenues.
