## **Debt Information**

As of Sept. 1, 2016

De Kalb Independent School District currently has one Maintenance Tax Note, one small Loan agreement for a tractor/backhoe, and no bonded debt.

In July 2013, the District executed a loan agreement for Maintenance Tax Notes, Series 2013 in the amount of \$730,000. The note proceeds were used for utility upgrades district-wide.

In September 2014, the District executed a loan agreement in the amount of \$19,968. The note proceeds were used to finance the balance of a tractor and backhoe.


