House Bill 3834 from the 2019 Legislative Session requires local government employees and elected officials (including school district employees who have access to a district computer system or database and all board members) to complete a certified cybersecurity training program by **June 14**, **2020.** The Texas Department of Information Resources (DIR) was required to certify at least five cybersecurity training programs, and the school district employees and board members must choose one to be completed by the June 14 deadline

After the required training is completed by school district employees who have access to district computer systems or databases and by all school board members, the District must certify compliance

with the training requirements by June 15, 2020. Districts may use the Cybersecurity Training Certification for Local Governments form to certify compliance. District policies addressing these requirements can be found at Board Policy CQB (Legal) and (Local).
