Dual Credit Checklist

High School student seeking college credit must have each of the following forms submitted to the Registrar's Office.

- ✓ Completed application that is found on the Admissions page of the Ranger College website.
- ✓ Copy of current high school transcript
- ✓ Official transcript from any other college that the student has attended as dual credit
- ✓ Copy of qualifying test scores:
 - ✓ Sophomore: TSI
 - ✓ Juniors: STAAR, TSI, PSAT, PLAN
 - ✓ Seniors: STAAR, TSI, ACT, SAT
- ✓ Parent permission form

*** The Registrar's office must receive a final HS transcript after the student graduates.**

**MULLIN ISD DUAL CREDIT/COLLEGE COURSES
PARENT/STUDENT AGREEMENT**

GENERAL INFORMATION

Mullin Independent School District, in conjunction with Ranger College (RC), offers dual credit for MISD students. By successfully completing these courses, students will receive high school and/or college credit. To receive weighted credit for a RC course, a student must be enrolled in the RC course and receive a passing grade in the course. All MISD rules and regulations apply to the student enrolled in the RC courses, including but not limited to the attendance laws and code of conduct. A dual credit student must be enrolled in MISD high school throughout the RC course, or he/she will be dropped from RC. MISD students must have a passing score on the TSI to be enrolled in RC courses.

MISD dual credit students will be treated as college students by the RC faculty. Neither RC nor MISD will provide progress reports or 6-weeks grades. The college professor will not notify parents or guardians if the student is absent and/or not turning in assignments.

In addition, the student's transcript will have a hold placed on it and/or no additional college enrollment will be allowed through MISD until such tuition costs are paid to MISD.
6. _____ I understand that the student must earn a grade of "C" or better in all courses in order to continue dual credit/college courses.
7. _____ I understand that students who earn a "D" or an "F" on their RC transcript will be required to return the cost of said course to MISD. I also understand that any student who earns a "D" or an "F" on his/her RC transcript will not be allowed to return to RC as a dual credit/college student for the remainder of his/her high school career and/or the student's transcript will have a hold placed on it until such tuition costs are paid to MISD.
