

**BOONEVILLE PUBLIC SCHOOLS
SCHOOL BOARD MEETING
SCHOOL BOARD ROOM
REGULAR MEETING
SEPTEMBER 11, 2007**

The Booneville School Board met in a regular meeting, September 11, 2007 at 6:00 p.m. with the following members present: Glynda McConnell (presiding officer), Sam Tabler, Pat Pace, Todd Preston, Don Murray, Clay Wiggins, and Bobby Ashley, School Superintendent.

Absent member was Beth Bryant.

Glynda McConnell called the meeting to order.

The minutes of the August 14, 2007 regular school board meeting were approved as read by unanimous consent.

The minutes of the August 30, 2007 called school board meeting were approved as read by unanimous consent.

The financial report was presented by Mr. Ashley.

Mr. Ashley reported that the total enrollment for the district is down approximately 20 students for this year.

Don Murray was presented a plaque and recognized for his years of service to the schools as a board member. Mr. Murray was commended by board members and Mr. Ashley for his dedication and compassion for the schools.

Mr. Ashley gave the board copies of a recent Booneville Democrat advertisement which was ran as a means of saying Thank You to the teachers for their hard work and dedication which resulted in our student having high scores on the 2006-2007 Benchmark Tests.

Mr. Ashley reported that the school district has been awarded a grant through the Arkansas Safe Routes To School (SRTS) Program in the amount of \$13,449.

Mr. Ashley reported on the Summer Feeding Program which was coordinated by Anne Jester.

A motion was made by Sam Tabler and seconded by Pat Pace to adopt the 2007-2008 school budget. Motion carried unanimously.

A motion was made by Todd Preston and seconded by Sam Tabler to accept the proposed credit recovery policy as presented by Mr. Ashley. Motion carried unanimously.

Mr. Ashley gave the board members an update on building projects within the district.

A motion was made by Clay Wiggins and seconded by Sam Tabler to approve a request from the FFA Show Team for an overnight trip to the Arkansas State Fair in Little Rock in October.

Mr. Ashley reminded the board of the Regional School Board Meeting which is scheduled for October 18 in Greenwood.

A motion to adjourn was made by Clay Wiggins and seconded by Todd Preston.

The meeting adjourned at 7:15 p.m.
