Pursuant to Section 3012 of the Education Law and in compliance with Part 30.3 of the Rules of the Board of Regents to appoint Enaw Elonge, of Ithaca, NY 14850, who holds Initial New York State Certification permitting her to teach Music PK-12 in the public schools of New York State, to the position of PK-6 Music Teacher in the Special Subjects (Music) tenure area for a probationary period of four years, to commence on August 27, 2018 and to expire on August 27, 2022 (unless extended in accordance with the law). This expiration date is tentative and conditional only.

Except to the extent required by the applicable provision of Section 3012-3 of the Education Law, in order to be granted tenure the teacher must receive composite or overall annual professional performance review ratings pursuant to Section 3012-c and/or 3012-d of the Education Law of either effective or highly effective in at least three (3) of the four (4) preceding years, and if the teacher receives an ineffective composite or overall rating in the final year of the probationary period the teacher shall not be eligible for tenure at that time; and that Enaw Elonge during her first year of this

appointment be paid at the annual salary as outlined in the agreement between the Dundee Teachers' Association and the Board of Education, dated July 1, 2017, as being the salary for a teacher on Step 1 of the current agreement plus any hours or degrees.
