Except to the extent required by the applicable provision of Section 3012-3 of the Education Law, in order to be granted tenure the teacher must receive composite or overall annual professional performance review ratings pursuant to Section 3012-c and/or 3012-d of the Education Law of either effective or highly effective in at least three (3) of the four (4) preceding years, and if the teacher receives an ineffective composite or overall rating in the final year of the probationary period the teacher shall not be eligible for tenure at that time; and that Katherine Romeo during her first year of this appointment be paid at the annual salary as outlined in the agreement between the Dundee Teachers' Association and the Board of Education, dated July 1, 2017, as being the salary for a teacher on Step 8 of the current agreement plus any hours or degrees.

**WHEREAS**, the Board of Education seeks to take steps to sell or otherwise transfer the above-referenced property.

### **NOW, THEREFORE**, be it resolved as follows:

- 1. The Board of Education of the Dundee Central School District hereby finds that the Property is of no use or value to the District, and that the conveyance of the District's interest therein is in the best interest of the District.
- 2. The Board of Education understands its fiduciary responsibility with respect to such sale and will make any and all further decisions with respect to the sale of such property in accordance with applicable provisions of law and its fiduciary obligations thereunder
- 3. Any offer to purchase the premises shall be subject to Board of Education approval and the regulations of the State Environmental Quality Review Act.
- 4. Any offer to purchase the premises shall also be subject to the provisions of New York Education Law Section 1804(6)(c), which may subject this action to a permissive referendum.
- 5. The officers and employees of the District are authorized and directed to take all steps necessary or appropriate to solicit bona fide offers and complete the transaction.
