AFFIDAVIT OF RESIDENCY

To Parent or Guardian: This affidavit is required when you reside in a place in which your name does not appear on utility bills. The affidavit is used only to assure Orcutt Union School District that you reside within our attendance area.

The Affidavit of Residence requires: Form must be completed in blue or black ink and two (2) proofs of residency (copies of current utility bills) from homeowner/renter be attached.

- 1. The student and the parent/guardian live at the address 7 days a week. A District staff member may make periodic visits to determine that the student continues to reside with the parent/guardian at the address listed below.
- 2. Further proof of residency may be required during the course of the school year.
- 3. Any change of address will revoke this permit at the end of the academic school year.
- 4. The District reserves the right to require the renewal of the Affidavit each year.
- 5. The Affidavit will be **revoked immediately if any information herein is found to be falsified. The district may refer the falsified affidavit to the Santa Barbara County District Attorney**.
