III. Curriculum/Accountability

A. Calendar Recommendations

- Nine week reasoning is that it balances out the semesters and eligibility can be regained at 3 weeks. Principals will ultimately decide on whether or not it is a six or nine weeks grading period.
- Votes for Thursday/Friday; 16 votes for Friday and Monday. Fall Break moved to October 22 and 25. Move the workday from April 11 to April 14. Move to add PLC day on January 17-18 votes. End of first nine weeks move to October 11. Moved September 21 holiday to November 29 holiday. April Austin moved to accept the calendar with given changes; Merribeth Henry seconded.

B. Update on DIP Revisions

- Goal 2: Levelland ISD will build a strong foundation of reading and

math to support all content area. The Performance Objective 1: Overall student performance as measured in Domain I will produce a STAAR performance greater than 75% as measured by scaling calculated scores of approaches, meets, and masters.

- New performance measures were added to accommodate the CARES Act and HB3.
 - Performance 5: Utilizes CARES Act Funding to provide needs for continued instructions (Face-to-Face and Virtual) during COVID-19 Pandemic.
 - Performance Objective 6: The percent of 3rd grade students that score meets grade level or above on STAAR reading will increase from 37% to 52% by June 2025.
 - Performance Objective 7: The percent of 3rd grade students that score meets grade level or above on STAAR Math will increase from 40% to 52% by June 2025.
 - Goal 4: Levelland ISD will improve areas of Low performance based on state and federal accountability.
 - Change the Objective 2 goal to be in compliance with state laws.
 - Performance Objective 2: Total disciplinary removals for students served in special education will be reduced by 20% to better align with the state rate during the 2020-2021

school year.
