The Bolton Board of Education held its regularly scheduled Business Meeting on November 9, 2016. Members present were Chair Liz Krueger, Andrew Broneill, Kate Gallé, Scott Rich and Alison Romkey. Superintendent Kristin Heckt was also present. BOE members Chris Davey and Stacy Reed were absent.

- A. Call to Order Chair Liz Krueger called the meeting to order at 6:30 PM.

Justin Wiles – Comcast Leaders and Achievers Scholarship Award Superintendent Heckt also noted that she, BHS Principal Joseph Maselli and staff member Jennifer Carvalho had just returned from Washington, D.C. where they received the 2016 National Blue Ribbon Schools award. Superintendent Heckt expressed her thanks and gratitude to **all** the staff and students in the Bolton School District as it takes the efforts of all for even just one district school to achieve such high recognition.
