Halal Menu

- A request was made that pre order forms be sent out in advance for students wanting Halal meals on a monthly basis.
- Aramark was not in agreement with the form since children order from the classroom on a daily basis.
- Aramark is exploring new recipes for more Halal options, especially meat options.
- Chicken nuggets or popcorn chicken is currently the only available option for Halal meats, but they do offer vegetarian options daily.
- A question was raised regarding cross contamination of Halal food and non-Halal foods.

Milk Shortage

- As of right now, NY is not affected by the milk shortage.
- The shortage is not the milk, it is actually the carton.
- Having milk poured on a daily basis for elementary school aged students is not an option so Aramark is looking into other options.
- The container shortage is also affecting the juice that is served.
- Aramark is aware and looking for options and will keep the School Districts posted.

Reimbursements

- Aramark has credited eligible meals to the School Bucks account.
- VSCHD is now in the process of transferring balances or issuing check refunds.
- Parents that requested a refund will be issued a check on or about December 15, 2023.
- Refunds only consist of eligible meals that were purchased prior to CEP which started as of July 1, 2023.
- School Bucks and cash are accepted forms of payment for alla carte options.

Household Income Eligibility Form

- VS 30 District is encouraging the community to fill out a Household Income Eligibility Form. The form is located on the Valley Stream 30 website, under the Community Section and in the CEP-Community Eligibility Program section.
- Meals will still be free.
- The form impacts grants that the District can receive.
- The forms can also make students eligible to cover SAT/PSAT fees, college application fees, for example.
- The income verification form will not impact the free lunch status but provide additional benefits.
- A CEP form will be sent out in December and we encourage all families to fill it out for benefits to the District and the VS 30 community.
