

**THE REGULAR MEETING OF THE BOARD OF EDUCATION
NASHVILLE SCHOOL DISTRICT
APRIL 16, 2012**

The regular meeting of the Nashville School District was called to order at the above date at 6:00. The meeting was called to order by President, Phillip Turner. Other members present were: Monica Clark, Mark Canaday, Randy Elliott, and Miles Mitchell.

A motion was made by Miles Mitchell to approve the minutes of the last meeting. Mark Canaday seconded the motion. It passed 5-0.

Superintendent Douglas Graham asked the board to approve the payment of bills. Randy Elliott made a motion to approve and Miles Mitchell seconded the motion. It passed 5-0.

The Elementary School Scrapper Singers, under the direction of Jaree Hall, performed 3 songs from a recent visit at the state capitol.

The board recognized the Nashville Junior High FCCLA for numerous awards and announced that they would be competing at the National Conference in July in Orlando, Florida.

Mr. Graham asked board to approve the 2012/2013 calendar chosen by the certified and classified PPC. Phillip Turner made the observation that Memorial Day was not on the calendar, noting that graduation was the Friday before that weekend. After much discussion, Mr. Graham asked the board to vote on all other dates on the 2012/2013 calendar, leaving the graduation date for a future meeting. Mark Canaday made a motion to amend the recommendation. Monica Clark seconded the motion. It passed 3-2. (Randy Elliott , against – Miles Mitchell, abstain)

Mr. Graham asked the board to consider two bids for a new bus. The lower bid was for a 2013 Blue Bird Vision for \$80,370.00. Miles Mitchell made a motion to approve the bid and Monica Clark seconded the motion. It passed 5-0.

Mr. Graham recommended adding \$500.00 to the salary schedule for 2011-2012. Randy Elliott questioned if everyone in the district would only receive \$500.00. Mr. Graham clarified that the \$500.00 was an adjustment to the salary schedule. Indexes would be multiplied with the new schedule and everyone on indexes would get raises proportional with their indexes. Mr. Elliott wanted indexes reviewed and Mr. Graham reminded him that the board reviews indexes in June. Miles Mitchell made a motion to adjust the salary schedule. Mark Canaday seconded the motion. It passed 5-0.

Mr. Graham presented the entire certified and classified staff for re-employment. Monica Clark made a motion to re-employ and Mark Canaday seconded the motion. It passed 4-1. (Randy Elliott, against)

The resignations of Vickie Beene, 7-12 Language Arts Academic Coach; Michael Howard, Assistant Senior Football and Basketball Coach; Lucia Hernandez, Primary School Teaching Aid were accepted with Mark Canaday making a motion and Miles Mitchell seconding. It passed 5-0.

At 6:45, Miles Mitchell made a motion to go to Executive Session to consider personnel matters. At 8:20 the regular meeting resumed.

Miles Mitchell made a motion to approve the employment. Mark Canaday seconded the motion. It passed 5-0.

Mr. Graham recommended Mike Ritchie for Senior Boys Basketball Coach. Mark Canaday made a motion to accept the recommendation and Monica Clark seconded the motion. It passed 4-1. (Miles Mitchell, against.)

Mr. Graham stated that a special board meeting would possibly be called for the following Thursday. The meeting was adjourned at 8:25.
