Minutes

1) Welcome – Jason Daniels

Jason welcomed everyone to the meeting and thanked them for attending

2) Review purpose of SHAC (handout)

Dalene Burns reviewed the statutes creating and defining the purpose of the SHAC committee

3) Review changes to SHAC legislative policy (handout)

Dalene Burns briefly explained the legislative policies that have governed the activities of the SHAC committee

4) Review Wellness Policy (FFA Local) and EHAA (LEGAL)

Dalene Burns gave each member a copy of the district health and wellness policy so members would have time to read the policy in preparation for the completion of the tri-annual survey at the next meeting

5) Review the tri-annual evaluation, Wellness Policy Audit Tool

The tri-annual survey will be discussed at the next meeting.

6) Approve committee leadership

a) Officially establish offices in Texas, officers should include chair and/or co-chair. Remember that at least the chair or co-chair must be a parent/guardian of a student enrolled in the school

district and cannot be an employee of the school district (TEC, Title 2, Chapter 28, §28.004).

Nominations were opened for the position of Co-Chair. Jason Daniels was nominated to serve again next year. Mr. Burns moved that Jason serve as the Co-Chair for 2022-2023 school year, Daniel Rosales seconded the motion. The motion was unanimously approved.

There were no nominations for secretary so the vote will be tabled until the next meeting.

7) Discuss and develop objectives for year

a) Discussions of areas or concerns the committee might want to address this year. *SHAC family night, COVID – 19, Mental Health Initiatives, etc.*

Jason discussed any areas of concern that the committee members might have. Two areas were discussed: Shack Family Night and Staff Health and Wellness program

b) Develop specific goal/objectives for the year.

i. By April 2023, the SHAC will develop and implement a Parent Involvement Health and Safety Night in order to provide assistance in implementing Texas Public Policy regulations in an effort to create a healthy school environment. Attendance will increase by 5% from last year's event.

ii. This event will be advertised locally on the TV station, in the local newspaper, on the Chamber of Commerce marquee, JH marquee, and Primary marquee. Flyers will be sent home with each student.

iii. SHAC committee wants to involve the City of Friona and the Friona Chamber of Commerce along with any other entities who might be interested.

iv. Mr. Woods will email SHAC committee attendees the information from last year's event.

8) Safety Audit Update, Technology Safety Update

Trish Winebrinner talked about the exterior door audit, the camera audit and the classroom door audits that are currently being conducted. Dalene Burns shared a handout with the safety initiatives for the district.

9) David Woods SHAC Parent Involvement Health and Safety Night

Dalene discussed the SHAC Parent Involvement Health and Safety Night available dates and suggested that November 17 would be a good day for the event. Jason Daniels suggested we adopt that day. The theme for the evening will be a carnival theme.

10) Cafeteria Update

Billy Maples shared the High School menu for September. He explained the menu cycle and meal offerings. Billy asked for feedback on the menu. No feedback was offered.

11) Nurses Update

Kay O'Brian informed the committee of upcoming events. Hearing, vision and scoliosis checks will be starting at all the campuses. There have been some flu cases, but no COVID cases reported.

12) Counselor Update

Angela Alexander from the Junior High share information on the student use of Google classroom to see their grades. It is also used for surveys and communication with the counselor. Choose me will continue this year to provide guidance lessons. Students will be nominated for student of the month and birthdays will be recognized each day. A teacher coloring poster has been put up in the teacher lounge to encourage teacher relaxation. Individual counseling will be offered and group counseling will occur during technology class.

Nancy Rosales shared information about the guidance lessons on campus. She shared a survey given to students about transitioning back to school. The guidance lessons for October will address Red Ribbon week for drug use and Bullying. Group during Tribe Time and Positive Action Curriculum will be used this year. Students may receive individual counseling using a self referral form or when the need for counseling is recommended. Cupcakes with the Counselor celebrates the student birthdays once each month. Nancy shared testing information; testing calendars are available and TELPAS testing practice will begin to help EB students get familiar with the testing format.

13) Physical Education Teachers Update

Daniel Rosales spoke about the PE program at the Junior High, Mayra Olivas will be teaching the class.

Trish Winebrinner will share information about the Fitness Gram at the next meeting.

15) ESSER 1, ESSER II, ESSER III update

Dalene Burns shared the planned expenditures for ESSER II and ESSER III. Committee input was requested; no input was offered.
