Proposed Construction Plans – At Dr. Byrd's instruction, Doug Harris explained to the Board the need for a Performing Arts Building on the Main Campus (where band practice field is) and an addition to the Elementary Building (where modular buildings are located) due to student growth. In order to receive Federal or State Funds including Matching Funds, applications had to be

submitted by February 1, 2014. Dr. Byrd and Doug Harris assured the Board that this did not commit the district to having to build, but due to timeline constraints, if the application was not submitted, it would be at least 2017 before the opportunity became available again.

Amend Issuance & Delivery of Bonds Resolution – A motion was made by Lydia King to adopt the Amending Resolution Concerning the Issuance and Delivery of Bonds. A unanimous vote followed.

Testing/Achievement Report – The Board received the Testing/Achievement Report. Mindy Hicks also updated the Board, at Dr. Byrd's request, on the ESEA Accountability Report that will be available to the public on November 5, 2013. The report shows Berryville School as a "Needs Improvement" district in Math and Literacy.

Update Present Phone System – A motion was made by Lydia King to approve updating the district's phone system for a one-time cost of \$18,790. A unanimous vote followed. The update would allow for better communication between offices in the event of an emergency. The expense would be paid for using Operating Technology Funds.
