District Learning Options:

1. Traditional Classrooms w/ Social Distancing

2. Temporary Virtual -

- a. Student is enrolled in the Traditional Setting and utilizes this option only when illness, bad weather, and/or unforseen events necessitate.
- b. Google Classroom utilized while the student is **temporarily** at home (due to illness, closed school site, etc.,

3. Full Virtual -

a. APPLICATION REQUIRED

- b. Student must have a designated at-home learning coach to assist student
- c. (1) One full semester commitment required
- d. Not eligible to participate in athletic/ extra-curricular activities
- e. Transfer students are not eligible for full virtual.
- · Rules/Guidelines must be identical across the district.

· MASKS

- All administration, certified and support are required to wear masks and/or face shields.
- Face shields students see mouth when teaching (mask covers nose and mouth)
- Students Masks are not required but highly recommended. This could change if mandated by the State Department of Education and/or Governor.

UPON ENTRY TO THE SCHOOL EACH DAY

- Temperatures taken with infrared thermometer each day. 100°+ a student will be taken to the building Covid-19/Isolation room and parents contacted..
- Teachers and staff will take each other's temperature and verify under 100 each day and log this information.
- Every teacher/coach will have a thermometer as well as the office and nurse.
- Every teacher/coach will take their class's temperature upon entering class and record it on a document.
- Parents can not enter the school building (no one besides students and employees)!! Anything that students forget to bring to school in the morning (lunch, folder, library book, homework) may not be brought or requested throughout the day. Parents will be allowed into the school buildings for emergencies ONLY!
- Unfortunately, there will be no Beautiful Day mentors or PTO volunteers this year.
- Parents & Students cannot congregate at entries before & after school. Everyone must practice social distancing (6 feet apart/family).
- More information to come regarding drop off & dismissal procedures to make it go smoothly and safely.

· TRANSPORTATION:

- o Traditional transportation will resume.
- o Encourage bus riders/students parents to provide transportation if possible.

- o Bus windows will be down to promote air circulation
- o Driver's will wear goggles and masks and create/maintain a seating chart for bus riders.
- o Any bus route rider/student MUST wear a mask.
- o Earliest arrival time for buses at sites is 7:35 am
- o Departure Loading Procedures will remain as in prior years.

· CHILD NUTRITION:

- o Self-serve options at lunch will no longer be available to reduce the number of touch points in the cafeteria. This includes salad bars, condiments, etc.
- o ES those who bring their lunches will eat in the classrooms
- o Cafeteria diners will eat in the cafeteria.
- o Lunch guests will not be permitted. Additionally, lunch drop offs will not be accepted either.
- o All Virtual learners and Temporary Virtual Learners will pick up their breakfast/lunch between 9:30 10:30 am daily from the ES cafeteria in a drivethru style.

· VISITORS IN BUILDINGS:

- O Visitors in buildings will not be permitted unless scheduled by the office staff. Anyone entering the building is strongly encouraged to wear a mask.
- o ANYONE who enters the school office must have their temperature taken and be encouraged to wear a mask while in the building.

· DRIVER'S EDUCATION:

- o Google Classroom may be utilized for classroom portion of class.
- o Virtual driving will resume should the need dictate and the OSDE approves.

LIBRARY/MEDIA CENTER:

- o Garland Smith Public Library cards will be given to all students who do not currently hold a card. Students will then have online access to reading/research/support materials via Internet.
- Marlow Public Schools utilizes EBSCO Host, an online consortium of research materials, that now includes e-books. Students are encouraged to utilize this software for reading materials, research materials, magazines, etc.

· SpEd/OT/PT:

- **o** All IEP meetings will be held virtually.
- o OT/PT cleaning/disinfecting plans will be provided to you ASAP.

· COMMUNICATION:

The district will communicate with parents/guardians/caregivers via PUSH notifications, Google Classroom, and the school's website (www.marlow.k12.ok.us). In the case of emergencies the district will utilize PUSH, local TV stations, KFXI radio, and the Marlow Review.

COVID-19 ISOLATION AREAS:

• Each site has designated a COVID-19 Isolation area prior to the start of school. Faculty/Staff should be aware of this area and avoid it if possible cases are present.

MEET-THE-TEACHER NIGHT:

- Meet-the-Teacher night will be a virtual experience this year.
- Principals will establish dates for parents to "drop off" school supplies for the classrooms.
- Your child(ren)'s school site will inform you about Meet-the-Teacher dates and times as well as the supplies "drop-off" times and locations.

EXTRA CURRICULAR/ACTIVITY PARTICIPATION:

o Students must be enrolled in the traditional learning option to be eligible for participation in extra-curricular/activities.

· CLEANING PROTOCOLS:

Classrooms/athletic facilities/buses will be cleaned, disinfected and fogged daily.

OUTSIDE AGENCIES USING DISTRICT FACILITIES:

o MPS has always been generous with facilities usage for outside agencies. Due to the current pandemic, this policy may have to be rethought as the District strives to slow/stop the spread of COVID-19. Additional information will be provided as it becomes available.
