Public Notice:

Morgan ISD receives a formula-funded grant annually called the Every Student Succeeds Act Consolidated Grant for Federal Funds. The purpose of these funds is to ensure that our most challenged and At-Risk students stay on track for graduation.

For 2021-2022, Morgan ISD received in Title I 211 an initial allocation of \$48,007, for Title II, A 255 the initial allocation is \$5,703 and for Title IV, A 289 an initial amount of \$10,000 will be received. Morgan ISD chooses to receive these funds in a way that provides the greatest flexibility for us as a school-wide Title I, A served campus and that means that we utilize REAP so that our Title II, A, and Title IV, A funds can all be used as if they serve the same purposes and intents as Title I, A funds. Morgan ISD will fund the following activities for 21-22 with these funds:

** Salary for a Pre-K paraprofessional and an ESL Liaison*

** Professional Development for all instructional staff and campus leaders to grow the instructional skill/leadership skills of the personnel on the campus*

** Funds for general supplies and materials to support student academic achievement*

** Funds for travel and conference registration to support educator growth and competencies*
