3. How will your school provide information to parents about volunteer opportunities (must include state mandated parent training)?

The Jack Robey Jr. High School will provide opportunities for parents and community members to support the instructional program through such programs as Dads on Duty, Classroom Moms, mentoring, band and choir parent sponsors, and after-school tutoring. The school will provide a list of volunteer opportunities and solicit ideas for other types of volunteer efforts during parent orientation. The parent facilitator will explain the requirements to parents and encourage them to become involved in the school. All volunteers must sign up at the district's Volunteers in Public School Office (V.I.P.S.), training sessions will provide parents and community members with the information they need to participate as school volunteers.

Jack Robey Jr. High School will work with Southeast Middle School and Belair Middle School to help provide a smooth transition from one school to the next by raising parent awareness of procedures and related activities. The school will host special orientation programs for parents and students to help with the transition.

The Parent and Family Resource Center is a program designed to encourage, enrich, and support parents in their efforts to be more involved in their child's education. A library of books and videos are available for check out for parents. The Parent and Family Resource Center is open to all parents who have children enrolled in the Pine Bluff School District.

Jack Robey Jr. High School shall require no fewer than two (2) hours of professional development for teachers designed to enhance the understanding of effective parental involvement strategies. Teachers will receive the first staff development on August 12, 2103. Jack Robey administrators will receive three (3) hours of professional development designed to enhance understanding of effective parent involvement strategies and the importance of administrative leadership in setting expectations and creating a climate conducive to parental participation.

Parents may check out materials, use the computer to check grades, and visit educational Web sites at the Pine Bluff School District Title I Parent and Family Resource Center. The Title I Parent & Family Resource Center is open from 8:00 a.m. - 4:30 p.m. Monday through Friday and the computer lab is open from 4:30 p.m.-6:30 p.m. Tuesday & Thursday & the 2<sup>nd</sup> & 4<sup>th</sup> Saturday of each month from 9:00 a.m.-12:00 noon. Parents will be encouraged to view the Title I Plan located in the parent resource center or media center. The school will open the resource center at hours that are convenient to parents.

During the August 15, 2013, Annual Title I Parent Meeting, Jack Robey Jr. High School will distribute Informational packets that includes a copy of the school's parental involvement plan, survey for volunteer interests, recommended roles for parents/ teachers/students and school, suggestions of ways parents can become involved in their child's education, parental involvement activities planned for the current school year and information about the system that will be used to allow parents and teachers to communicate (notes, phone calls, e-mail, etc.)
