34th Avenue Elementary will distribute a monthly calendar to parents that is developed with participation of the parent-school organization, principal, staff and parent volunteers. It includes school news, a calendar of school activities, and parenting tips related to school achievement such as homework tips, organizational skills, and study skills.

34th reading specialist and parent volunteers will create a pamphlet explaining the school's involvement with the state's reading initiative and how the parents can be involved in supporting the goals of this initiative.

34th will provide to parents reports/report cards every four weeks with information regarding their child's academic progress and upcoming classroom and school events.

34th will offer parents a special workshop each year on the school's approach to school improvement.

34th reading specialist and parent volunteers will create a pamphlet explaining the school's involvement with the state's reading initiative and how the parents can be involved in supporting the goals of this initiative.

34th will provide to parents reports/report cards every four weeks with information regarding their child's academic progress and upcoming classroom and school events.

34th will offer parents a special workshop each year on the school's approach to school improvement .Math and Literacy nights will include parent training sessions to help parents understand how to enhance their child's education.

Outside speakers will provide parents with more information concerning ways to make their child's academic life more successful.

Teachers will hold conferences individually with parents of children in their classrooms. Parents will be given a summary of the student's test scores and an explanation of the interventions teachers are using to assist the child in reading achievement goals. Parents will be asked to engage in discussion of how they can support these efforts. Parents will also be given suggestions for coordinating school-parent efforts and explanations of homework and grading procedures.

34th will encourage parents in the following types of roles and activities to increase their involvement and support for student learning: reading buddy, teacher assistant, tutor, special parent lunches, Grandparents Day, awards day presentation, field day volunteers, open house, parent-school organization, red ribbon week, and various committees.

34th will provide a list of volunteer opportunities and solicit ideas for other types of volunteer efforts during orientation of parents. Teachers will explain the requirements to parents and encourage them to become involved in the school.

34th will work with Belair Middle School and Southeast Middle School to help provide a smooth transition from one school to the next by raising parent awareness of procedures and related activities.

34th will provide instruction to a parent on how to incorporate developmentally appropriate learning activities in the home environment, including without limitation: role play and demonstration by trained volunteer, the use of and access to the Department of Education website tools for parents, assistance with nutritional meal planning and preparation and other strategies or curriculum developed or acquired by the school district for at home parental instruction approved by the Department of Education.
