Where: Tennis courts located behind AMS/AHS.

Drop off/Pick up; Access the courts for drop off/pick up entering on the north side of the high school using the access road. Drive to the back parking lot by the Tennis/Baseball/Softball complex.

Cost: You can pay for a day, the week or for one of the two sessions.
➤ Grades 7-12 the cost is \$33 dollars for a week (\$11 a day) or \$90 dollars for all three weeks.

Please have your registration and payment with you on the first day of camp. Please make checks payable to “John Garrison”.

Camp T-shirt; Students participating in one session (paid for all 3 weeks) a camp T-shirt is included in the cost.

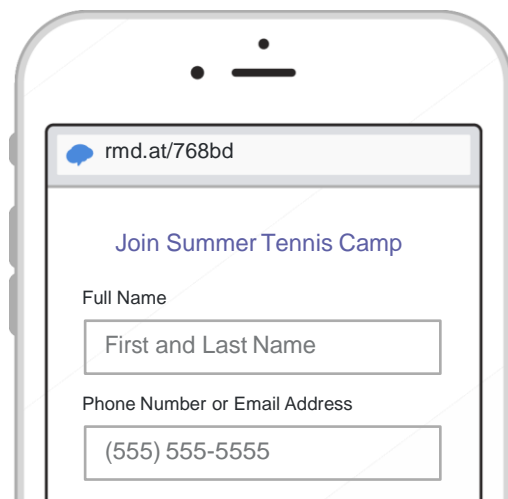
