Dates of Lessons: Session 1 - June 15, 16, 17, 22, 23, 24, 29, 30, July 1
(Tu, We, Th) Session 2 - July 13, 14, 15, 20, 21, 22, 27, 28, 29
(Each session is three weeks long. Make up for rainouts on Monday or Friday)

Time of Sessions: 1st thru 5th Grade - 8 AM - 9 AM
6th thru 8th Grade - 9:00 AM -10:30 AM
9th thru 12th Grade - 10:30 AM - 12 noon.

Where: Tennis courts located behind Andover Middle School.

Cost: You can pay for a day, the week or for one of the two sessions.

- Grades K-5 the cost is \$18 a week, \$50 for a session (3 weeks) or \$90 for both sessions
- Grades 6-12 the cost is \$33 dollars for a week, \$90 dollars for a session (3 weeks) or \$175 for both sessions.

If paying by check please make it payable to “John Garrison”. You may turn in payment on the first day of camp or you can bring them by the Andover Middle School office during normal school operating hours prior to the start of camp.

Participants who have signed up for a 3 week session will receive a camp T-shirt.

What to Bring: Tennis racquet, water, sunscreen, towel.

Lessons: The AMS Summer Group Tennis Lessons are designed to improve the skills of the novice player and enhance the skills of the experienced players. Each class includes instruction and playing of other students at their own level.

Tournaments: If available, coaches will provide summer tournament information to attending participants. We do not expect students to play in the tournaments but we encourage them to play to help improve their game. Tournaments range anywhere from novice (beginners) to Opens (more experienced players).

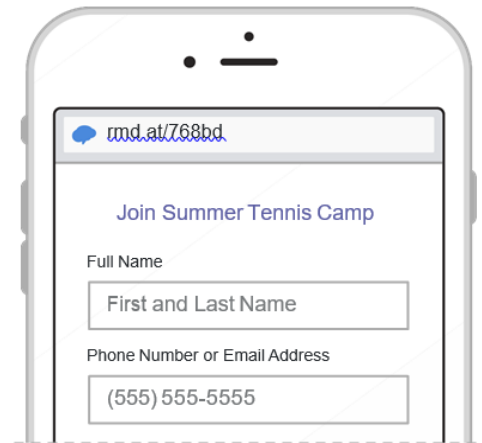
