Our overall attendance has gone down 2 percentage points from 15-16 to 16-17 and even more this year. Our attendance rates are on a downward trend and our chronic absenteeism rate (students missing 10% or more) is on the rise. School MUST be a priority. EVERYDAY, ALL DAY Matters!! Please do not allow your child to miss school unless it is for an appointment that cannot be scheduled before or after school. Attendance is important! It is important that your child comes to school on time, every day well rested and ready to learn.
Regular attendance is critical for your child to achieve his/her highest potential.
Academic and social learning takes place all day, every day at Plato. Students who arrive late, leave early, or are absent miss valuable instruction time.

A missed school day is a lost opportunity for students to learn. We can't teach our students if they aren't here. Any absence, whether excused or not, denies students the opportunity to learn in accordance with the school's instructional program, but students who miss school are sometimes further excluded from learning opportunities as a consequence of chronic absenteeism.
