In accordance with 62 O.S. 2011, § 354, notice is hereby given that the Board of Education of Elementary School District Number 96 of Grady County, Oklahoma, will receive bids by: sealed bid, facsimile bid, electronic (Parity®) bid or similar secure electronic bid on the 15th day of May, 2020, at 12:45 o'clock p.m., at the Middleberg School Library, Middleberg Junior High Building, Middleberg Public Schools, 2130 County Road 1317, Blanchard, Oklahoma, for the sale of \$290,000 of General Obligation Transportation Equipment Bonds of said School District, which Bonds will mature \$140,000 annually in two (2) years from their date, and \$150,000 annually each year thereafter until paid. The bids will be opened and read and shall be awarded at the first Board of Education meeting held after the bids are due.
