BOARD OF EDUCATION SPECIAL MEETING MINUTES
Friday, March 20, 2020

I. CALL TO ORDER:

Board President, Wade Tucker, called the meeting to order at 7:00 p.m.

II. APPROVAL OF AGENDA:

Sheila made a motion to approve the agenda as presented. Matt seconded the motion. Motion carried 7-0.

III. INFORMATION/DISCUSSION/ACTION ITEMS:

A. Update about school closing (I/D/A)

Mr. Horn updated the board about all that he has learned thru the meetings that Dale Dennis has been having daily. Mr. Horn has gotten a plan together but it is not due until April 8th so he will wait till closer to time to submit it. Surveys have gone out to parents and teachers. Trevor and Andrea both listed the problems that they will foresee in the next few weeks.

B. Classified Staff Pay (I/D/A)

A waiver will have to be signed that states the 1116 hours required to be open by the state. Mr. Horn has it filled out and will be asking for the waiver of 210 hours. Mr. Horn also said that we will still be paying our Classified Employees the normal hours that they would have been paid during the school year. Chantry made a motion to approve the Waiver for the 1116 hours required by the State. Sheila seconded the motion. Motion carried 7-0.

C. Food Service (I/D/A)

Curbside- Grab and Go meals will start on Monday March 23rd for all the kids ages 1-18 years of age. There will be three places for pickup for the students: In front of the High School, Big Bow and in Manter. If requested, there can be a normal bus route

that will be able to drop off meals. The sacks will contact Lunch for that day and Breakfast for the following morning. The cooks, Tina Parks, Donnie Morgan, Trenton Horn and Ivonne Gonzalez are already associated with the food program so therefore they are the ones that can do it right now. If other help, Sara Cox will have to train them before they can do it service. Rhett Seyb asked about reimbursing parents on their lunch accounts. Mr. Horn said that we will have to reimburse if they don't want to carryover their amounts for next year.

D. Technology (I/D/A)

Donnie Morgan said that she is figuring out what all she will have to do to get Chromebooks to the kids and is already halfway gone thru them. She is concerned about internet access for some of these kids and have talked to Pioneer Communications about what can be done.
