Install new like maple flooring

Sand gym floor to remove all finish and game lines leaving a smooth clean surface. Final disc sand to help remove raised grain from drum sanding.

Apply 2 coats oil-modified urethane seal. After final coat has dried abrade with 120 grit screen, vacuum and tack floor.

Tape and paint requested game lines in customer selected colors

Apply 2 coats oil-modified urethane finish.
