November Board Meeting Summary

Livingston ISD Board President Ben Ogletree opened the November board meeting a public hearing for FIRST report. Ben Davidson, LISD Chief Financial Officer presented the Financial Integrity Rating System of Texas (FIRST) for the 2017-2018 school year. Davidson shared how a district receives four possible ratings of an A, B, C or F, and LISD received an A rating with a score of 100. There are fifteen indicators and a perfect score was received on each indicator. The meeting continued with staff and student recognition. School Resource Officer Tremaine Bogany was introduced by Superintendent Dr. Brent Hawkins. Officer Bogany will office at the Cedar Grove Elementary campus but will work with the other School Resource Officers in providing support to all Elementary campuses. Dr. Hawkins recognized Class of 2019 graduate Teddy Kendrick as an outstanding performer at the 2019 Texas State Solo-Ensemble Vocal Solo Contest. Of the approximately 100,000 students participating in the regional music contests and the 25,000 musicians who performed at TSSEC, only 2%-3% of the solo performances earned the distinguished honor of being recognized as an Outstanding Per-

former. The medallion he was presented was

identical to those awarded to state champions in all UIL events. Hawkins shared, "Awards of this nature do not come easily and reflect the efforts of many individuals including LHS Choir Director Tom Myers and accompanist Marless Owen. LHS Principal Dr. Paul Drake recognized the Livingston Royal Brigade on received straight 1 ratings at the UIL Marching Contest on Saturday, October 19 at Port Neches-Groves. Dr. Hawkins presented a report on the Teacher Incentive Allotment. Under House Bill 3, a voluntary program is offered to Texas School Districts to allow an incentive allotment to teachers tied to student outcomes. TEA is requiring a plan to be submitted by the district and must be approved by the state. Teachers will be evaluated using the T-TESS evaluation system and assessed by student data in three categories as recognized, exemplary or masters. In a non-rural school district serving


