## Notice of District Regular Meeting Board of Trustees Northside Independent School District

Notice is hereby given that on August 19, 2021, the Board of Trustees of the Northside Independent School District will convene a regular meeting at 4:00 p.m. in the board conference room.

In keeping with the safety and health concerns related to the COVID-19 virus, Northside ISD will observe certain social distancing guidelines and will limit attendance at this and all public meetings to less than ten people.

Public Comment: Members of the public who desire to address the board regarding an item on this agenda must comply with the following registration procedures: Members of the public seeking to provide comments concerning an agenda item shall be required to register to provide comment by sending an email to the Business Manager of Schools at karen.skinner@esc9.net no later than \_2;00\_\_p.m. the day of the board meeting indicating the (1) person's name; (2) Subject the Member of the Public wishes to discuss, and; (3) telephone number at which the Member of the Public may be reached.

When it is time for the portion of the meeting to listen to registered public comments for agenda items, the District shall attempt to contact the registrant in the order in which the registration was received. If for any reason the registrant does not answer the call, the Board will proceed to call the next registrant. This process shall continue until the list of registrants has been exhausted. The registrant will have 5 minutes to provide public comment concerning the subject identified by the registrant. If a registrant does not speak English they must indicate so when registering and list the name of their translator, and additional time shall be provided in accordance with law. If a registrant requires the use of a TTY system, the registrant must indicate this requirement at the time of registration and the registrant shall be allowed to communicate on a topic for twice the amount of time allowed for persons not requiring the use of the TTY system.
