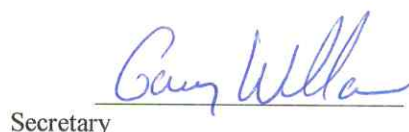

Kelvin Gragg, President recognized Craig Dupuy, Superintendent for Cleveland County and Nick Hill, Superintendent for Dewitt Schools.

Ranell Eubanks, Bus Driver Testing Coordinator updated the board on specific rules for Drug and Alcohol Testing of Bus Drivers.

- Replacement of Carpet , as needed

A motion was made by Chris Ferrell, second by Dr. Tracy Tucker to approve the purchase of a new co-op car on State Bid List and that the 2012 Ford Fusion be used for the car pool. All others voted in favor of.

MOU /ADE & ESC Works: A motion was made by Chris Ferrell, second by Tracy Streeter to accept a MOU entered into between the ADE and the Southeast Arkansas Education Service Cooperative to allow ADE to join the arranged group of educational entities partnered in the use of the ESC Works online professional record tool. ADE will become an additional, equal partner, paying for one share of the cost of the contract. All others voted in favor of.
