Narrative Reports

My basic love of safety systems and design were strong motivating forces early in my engineering career and laid the foundation for subsequent contributions to patient safety, event analysis, and systems improvement. I have been fortunate to integrate my proficiency in aviation safety with expertise in internal medicine to advance as a leader and educator of patient safety, systems analysis and design, and health care quality.

For a decade prior to my medical training, I served as an electrical engineer and project manager for the 757/767 flight management systems. The flight management system integrated technologies to improve efficiency and flight safety into cockpit decision support tools using human factors design. After residency I practiced and supervised residents in primary care at the Brigham and Women's Hospital, and served as Associate Medical Director and as Associate Director of Clinical and Quality Analysis. When the 1999 landmark Institute of Medicine report established patient safety as a national priority, I became committed to clinical quality improvement using engineering and systems principles to improve health care delivery.

As Director of Health Care Quality at Newton Wellesley Hospital, I established an integrated quality program. In 2002 I created a tool for developing guidelines that I've since used to lead numerous teams in the successful completion of clinical protocols. When the first Seminar on Patient Safety was held in Salzburg, Austria I was among those invited to introduce an international patient safety agenda.

As the first Chairwoman, I founded a Department of Quality and Patient Safety at Mount Auburn Hospital. We achieved "six sigma reliability" with technology and medication safety, developed award-winning disclosure programs, and established an approach to learning from adverse events with systems change that informs state-wide education. Special expertise in this area led to my inclusion in the inaugural World Health Organization Alliance for Patient Safety.

In 2005, I launched a clinical elective in Quality for medical residents; in that year I also convened regional physician quality officers who still meet bi-monthly for peer teaching. In 2010, I co-founded the formal professional Society of Physician Quality Officers and now serve as President.

Along with five other HMS colleagues, we launched a new HMS Quality and Patient Safety Fellowship July 2012; as the Curriculum Director for the Fellowship, I have led the development of a two year comprehensive curriculum. I initiated a Quality Grand Rounds bi-annual series at Mount Auburn Hospital, along with a bi-monthly Quality M&M to share case-based systems analysis and learning. An upcoming state-wide program to educate emerging quality leaders will be based on the content of my manuscript, "Root Cause Analysis and Action: Integrating Analytics and Humanism to Achieve Meaningful Results." I now serve on three Massachusetts Expert Panels in quality.

I have recently served as a consultant and educator, bringing education about structure and best practices to organizations, mentoring colleagues daily during programmatic implementation, and formally teaching. I now enjoy a widening educational role at the regional level, and am enthusiastic about expanding opportunities to share ongoing knowledge and provide mentorship for emerging physician leaders about effective leadership to assure quality, patient safety, and outcomes
