#### MANAGEMENT HIGHLIGHTS

Supervised and managed a 40,000 visit per year emergency department staffed by 14 Physicians and Physician Assistants from 2004 to 2008. Patient satisfaction scores were consistently above 90 percentile throughout my tenure as medical director of the emergency department.
