## Reportar extorsiones telefonicas mexico

How many attempts at extortion or phone fraud are actually committed in Mexico? It's not known for sure, but it's a crime that can happen to almost any citizen, so you have to be prepared. The Citizens' Council for Security and Justice in Mexico City, an organization that has been documenting the issue of extortion for more than a decade, said it received 21,410 calls from people who had suffered attempted extortion between January and September 2019. Read more: What is the drop-by-drop system with which people are blackmailed on CDMX? That's an average of 80 new extortion attempts every day, and it's just cases that people report to the body. The positive fact is that only 7% of these extortion attempts were saturated with payment from the victim, but given the size of the problem, this means that enough blackmail is consumed to continue and grow such crime. The key to resolving this situation, according to Salvador Guerrero Chiprés, President of the Civic Council, is to know what to do when that happens. Only then can the impact of blackmail be reduced. 92% of extortion attempts in Mexico take place by phone. It's the world. We need to build a platform of trust and information to protect families, the elderly from blackmail. The key is prevention, said Guerrero Chiprés. What are the most common ways of doing this when this happens, and why is it not possible to know with certainty the actual number of cases occurring in the country? We'll explain the keys. The most common scams The citizens' council has identified the most common ways in which criminals seek information or economic resources from victims from reports of extortion received in 2019. The most common method is so-called election calls, with which - under the promise of some kind of promotion, travel or prize - criminals manage to obtain personal data from victims, from names or addresses that can then be occupied for extortion, to bank information. Of the 21,410 blackmail messages received between January and September 2019, 34% were of this type. The second type is so-called kidnappings, with 25.2% of cases. It consists of asking for money from the victim by believing that his relative had been kidnapped. Criminals try to deceive a person by give him data that can be trusted by an alleged kidnapped relative, or simulating voices of anxiety. The third most common modality is threats with 21%. It is very only on the previous one, instead of simulating the kidnapping of a family member, is simply promised to hurt him if in return no good or payment is received. The following are calls from alleged members of criminal organisations, with 17%. The peculiarity is that extortionists pretend to belong to a cartel or criminal group to put pressure on the victim if the payment is not terminated. Another less common way, but also occurs, with 1.7% of cases, are extortion under the simulation of floor rights, that is, if the payment is required under the (false) threat of attack on some business person who tries to deceive, if he does not pay a certain amount. The council also recorded 212 extortion calls equal to 1% of cases in which money is demanded in exchange for providing information to the victim about their partner's alleged infidelity. The President of the Council has warned that extortion is a complex crime that has evolved over at least the last 25 years, when new ways or patterns are often emerging that adapt to work. Blackmailers build scripts powered by structures already highly studied and exploited in the past two decades that they specialize in, and this is based on the logic of dialogue, which seeks to create a sense of urgency where often one or two figures, which are not necessarily true but trustworthy, are often used. Hanging, verifying and reporting (and downloading applications) Blackmailer phone or scammers, explained the President of the Council, support the success of his fraud in the basic goal: to create as quickly as possible a sense of obtusion and urgency in the face of the possibility of danger or a sense of greed or exploitation in the face of an alleged extraordinary opportunity. The key to preventing the abuse of such activities is to break communication with the offender as quickly as possible. Guerrero Chiprés recommends as a first step downloading an application called No More Extortion - No More XT, which is available for free on mobile phones running Android or iOS, and which has a database of more than 150 thousand numbers from which extortion is committed. What the application does, after a simple setup, is to block the call or trigger a notification to the user in case he receives a call from one of the number blackmailers who are already preinstalled. Similarly, it allows register the number from which he detected possible extortion. On the other hand, if a person comes to answer a call for possible blackmail either because they got it on a landline or because they don't have a request on their phone, the Citizens Advice recommends a three-step plan: hang, verify and report. It's common sense. More than 90% of extortion attempts fail because people hang up. But to stop those that are realized formula is simple. If there is a sense of urgency that wants to force you on so you can decide something, you have to hang up, he said. The second step, especially in cases where you try to deceive a person with an alleged risk that a family member would be in, is to verify that they are ok. Guerrero Chiprés recommends having some method or protocol with close relatives to quickly check that everything is fine. The final step is to denounce the attempted extortion before the prosecutor's office. To facilitate this process, the Council has a team of lawyers and advisers who can advise or accompany a person in the complaint process free of charge. Psychological support can also be provided in serious situations where the blackmailed person is affected. As soon as the blackmail research file is launched, the automatically reported number enters a list of the extortionate number that the app has, the Council President added. The extortion, which is hidden According to official figures of the Executive Secretariat of the National System of Public Security (SESNSP), between January and November 2019, 7,000 investigative units were launched across the country for alleged extortion attempts of all kinds. In a specific Mexico City case, a spokesman for the local attorney general's office, Ulysses Lara, yesterday announced the opening of 131 investigative units from 5 December 2018 to December 31, 2019 for the same crime in which 228 people were arrested, 143 of whom were brought to justice and a total of 129 related to the court. According to the authorities and experts on the subject, this is a figure completely removed from reality. Proof of this is that the Citizens' Council received reports of more than 21 000 extortion attempts between January and September only. This huge pode registration has two explanations. The first has a lot to do with the lack of case reporting. According to the Council, the black figure of unreported blackmail represents 98 percent. In addition, a change in reported cases is added. According to an official audit of SESNSP incident data, which has not yet been made public, there are prosecutors in the country who pre-classify facts that are clearly alleged extortion to criminalise them as minor crimes such as threats. When the alleged offender shows up at the facility or property to demand payment at risk, it is direct blackmail. Precautions Do not provide personal or family information to strangers, including where surveys, interviews, or commercial promotions are applied. Keep in touch with your family. It is important to know where you are, with whom and when you plan to go home. Don't make recommendations from family members or friends without fully verifying the identity of the person who requests it. Have a phone book with family, neighbors, close friends and emergency numbers at hand. If they call you saying they've been called off the phone and that's not true, don't provide any information. It indicates that it was a mistake and hangs up. If someone asks you who I'm talking to when you answer a call, answer who you want to talk to? If you don't get an answer, hang up. Avoid entering personal information into pc sharing. Install the caller ID at home. Make sure your phone number is confidential and doesn't appear in public directories, where it usually appears with your address. Regularly download important photos and files from your phone's memory so they don't use this information against you if you're stolen or lost. Don't show personal information, photos, or videos on open social media profiles. Configure your account's privacy to your convenience. If you use online banking or perform government online procedures, be sure to check the severity and security of the site. Recommendations in case of extortion Before a phone call in which you are sure that a family member is abducted or detained by any authority, or in which they present you as members of a criminal organization in which they threaten to cause harm if they are not to the requirements, consider the following measures: Maintain calm and value of the situation raised objectively. Listen carefully to the arguments extortionist.com. Don't be able to control the emotional impact because you can act without thinking. Listen carefully, and then stop the call. He checks to see if the situation they pose is real, looking for a relative who has allegedly been kidnapped or is about to appear before the office. Write down the data of the people who are threatening, as well as the phone number from which it is called. It contains data such as date, time, name, voice tone, as well as how the request was made (sending money, depositing into bank accounts, card codes, etc.). Do not give up the economic requirements or demands of those who seek to blackmail or cheat. They don't negotiate any economic sum.
