- All orders are COD until credit terms (Net 15) are established following a provisional period with PCFA as well as a credit pattern of prompt bill payment with current suppliers.
- A 1.5% finance charge per month will be charged to all overdue open invoices.
- If an overdue occurs, Penn's Corner reserves the right to refuse new orders or require payment upon delivery until the account is current.
- All accounts are required to have a credit card on file. In the event that an account reaches 60 days past due, a charge will be made to the credit card to cover the past due balance.

Weekly Schedule

- Order from 1pm Monday – 4pm Tuesday for Thursday PM/Friday delivery (depending on location).
- Order from 1pm Wednesday – 4pm Friday for Tuesday/Wednesday delivery (depending on location).

Minimum Orders

- There is no minimum order requirement if you can pick-up your order at our warehouse in Lawrenceville.
- Based on delivery location and time of year, PCFA reserves the right to increase the minimum order required.

For locations Pittsburgh (East End, Downtown, South Side, North Side)

- Tuesday/Wednesday delivery requires a \$75 order with a \$15 delivery fee. Orders over \$100 include free delivery.
- Thursday/Friday delivery requires a \$100 order with a \$15 delivery fee. Orders over \$150 include free delivery.

For locations outside of Pittsburgh (including South Hills, North Hills, Sewickley, Monroeville, etc.)

- All order periods require a \$150 order with a \$15 delivery fee. Orders over \$200 include free delivery.

Returns

- Satisfaction is guaranteed on all products. However, due to the perishable nature of the products, all returns must be requested within 24 hours of accepting delivery.
