


Function:

MQTT is a powerful IoT protocol that has developed into a standard in many industrial automation applications. The PFC200 controller (generation 2) and the touch panel 600 support an MQTT connection by default. With "Multi Cloud Connectivity", the parallel connection of a device to two different cloud systems, IoT platforms or MQTT brokers is possible. This means that different tasks can be implemented in the appropriate cloud application. For example, device management is possible in the WAGO cloud, while specific tasks are carried out in another cloud solution, e.g. B. on IBM Watson, Amazon Web Services (AWS) or another specialized IoT platform. The data can also be split up. The critical data can go to a local MQTT broker and the less critical data to a cloud.
