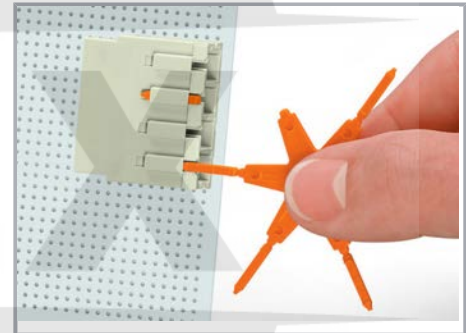
Coding
