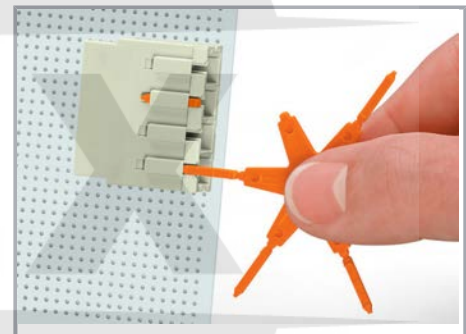
Coding
